**ARTICLE I

MEMBERS

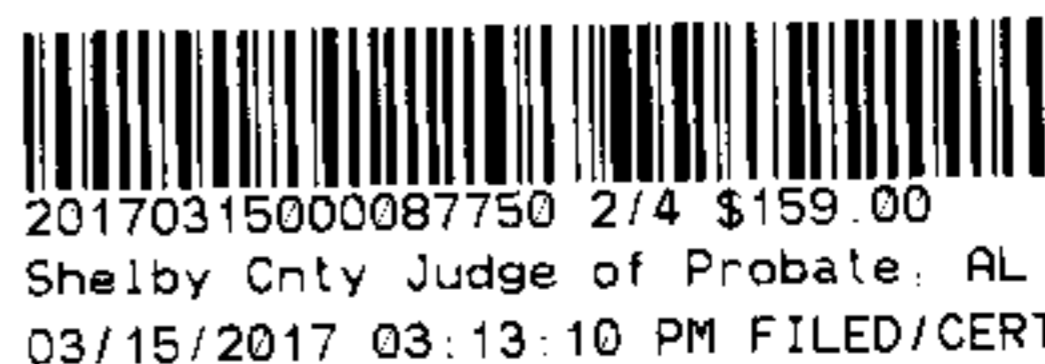

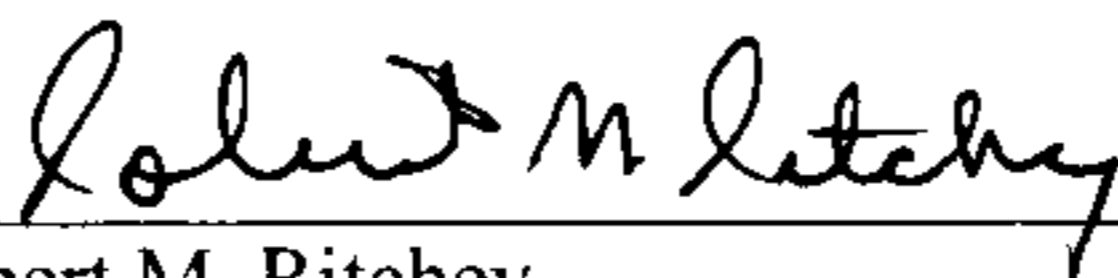

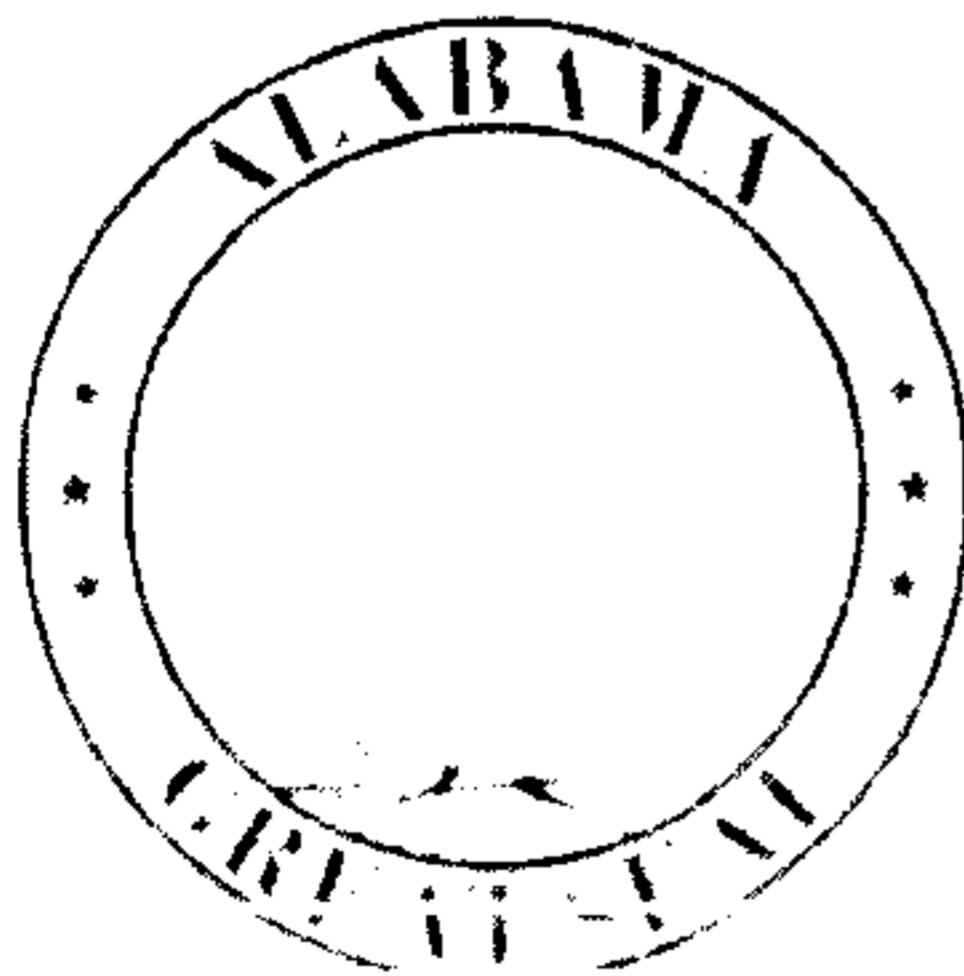
