LEGAL DESCRIPTION

Lot 1 and the West 50 feet of Lot 2, Hannah Gwin Subdivision, recorded in Map Book 30, at Page 47 in the Judge of Probate Office, Shelby County, Alabama, and being more particularly described as follows:

Commencing at the Southwest corner of the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 30, Township 21 South, Range 2 West, thence South 86 degrees 35 minutes 38 seconds West for a distance of 129.93 feet to the Point of Beginning; thence North 00 degrees 32 minutes 00 seconds West for a distance of 511.67 feet to a $\frac{1}{2}$ inch rebar found; thence South 86 degrees 59 minutes 19 seconds East for a distance of 337.87 feet to a $\frac{5}{8}$ inch rebar set; thence South 00 degrees 32 minutes 00 seconds East for a distance of 578.53 feet to a $\frac{5}{8}$ inch rebar set and the North right-of-way line of Shelby County Highway 12 (80 foot right-of-way); thence along said right-of-way with a curve turning to the left, having an arc length of 337.98 feet, with a radius of 4287.73 feet, a chord bearing of North 86 degrees 56 minutes 24 seconds West, and a chord length of 337.89 feet, to a 1 inch crimp top pipe found; thence leaving said North right-of-way line, North 00 degrees 32 minutes 00 seconds West a distance of 66.57 feet to the Point of Beginning.
