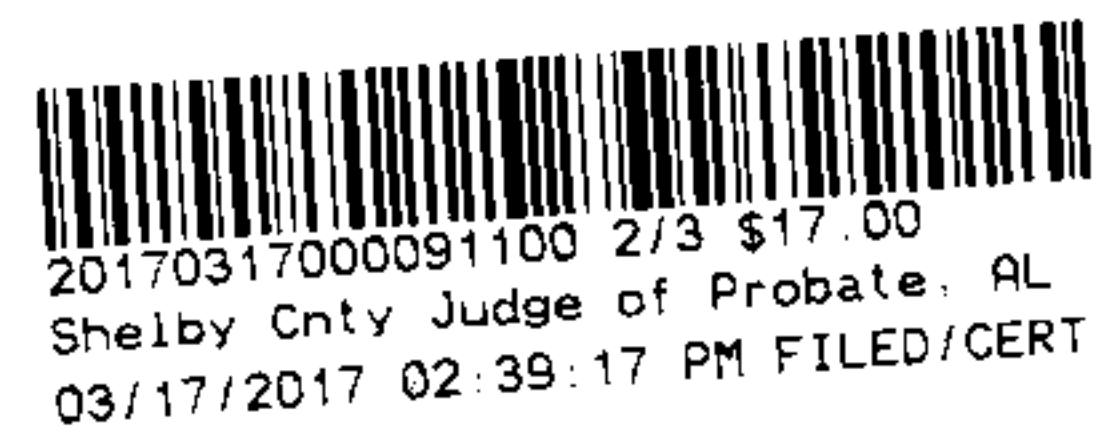

4. The description of all real property owned by or conveyed to the Trust is:
- Lot 13, according to the Survey of Quail Run Phase III, as recorded in Map Book 7, page 189, in the Probate Office of Shelby County, Alabama.***
5. The administrative or managerial powers of the Trustee in a pending transaction or relevant to the request:
- All powers contained in Article 8 of the Mississippi Uniform Trust Code (Sections 91-8-101 through 91-8-817 of the Mississippi Code of 1972, as amended).
6. During the lifetime of the Grantor, this Trust may be amended or revoked. Upon the death of the Grantor, this Trust shall become irrevocable.
7. When and if co-trustees are serving, they, in their discretion, may designate any one or more of them to perform ministerial acts in connection with the administration of the trust without the joinder of the others, including (but not limited to) the signing of checks and the issuance of receipts for money received and the depositing thereof to the trust's account. All other acts require execution by all co-trustees serving thereunder.
8. If the Grantor becomes unable (by reason of Grantor's death or incapacity) or unwilling to serve as Trustee hereunder, then the Grantor's son, **STEPHEN H. GALLOWAY**, shall serve as successor Trustee.
- A certified copy of the Grantor's death certificate shall serve as evidence of death. Further, a determination of the Grantor's disability or incapacity shall require the affidavits of two (2) physicians duly licensed in any State, stating that they have personally examined the Grantor and have determined to a reasonable degree of medical certainty that she is incapable of managing her own affairs.
9. As per Treasury Regs. - 1.67-4(b) & 301.6109-1(a)(2), it is not necessary for the Grantor to establish a separate tax ID number for a revocable living trust provided the Grantor is serving as Trustee. Therefore, the Grantor's social security number may be used for reporting purposes until further notice.
10. All property may be taken by the trust in the following name:
- (a) Judy Hasting Hyde Revocable Trust, dated January 23, 2017; or
- (b) Judy Hasting Hyde, Trustee under the Judy Hasting Hyde Revocable Trust, dated January 23, 2017.



11. The anticipated date of termination of the trust is:

Upon the distribution of all assets of the Trust or revocation of the Trust by the Grantor. The Trust has not been revoked or amended as to any information contained herein as of the date of execution of this Certificate of Trust.

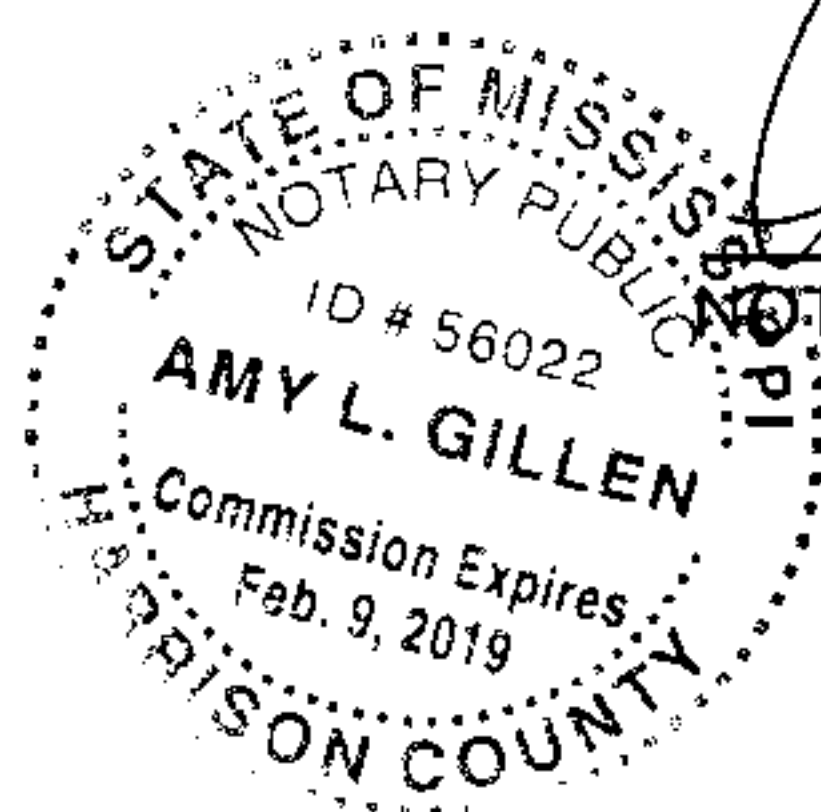
