FINAL ORDER

This Court enters this Final Order so as to adjudicate fully Plaintiff's in rem quiet title action as follows:

As shown by the partial release of judgment executed by defendant Lake Mitchell Construction, Inc. ("LMC") which is recorded in the Office of the Judge of Probate of Shelby County, Alabama (the "Probate Office") at Instrument 2017022100061550 (see Exhibit A), LMC has released its judgment lien solely as to the real property which is the subject matter of this litigation and which is more particularly described as:

The East ½ of the SE quarter of the SW quarter, Section 22. Township 21 South, Range 1 East, and all that part of the East ½ of the NE ¼ of the NW ¼ of Section 27, Township 21 South, Range 1 East, lying North of Lay Lake, Shelby County, Alabama (the "Property").

Previously on December 28, 2016 this Court entered a default judgment against defendants Regions Bank and Centennial Bank (see Exhibit C). On September 19,

2014, defendant Alabama Power Company was dismissed as a defendant given that Alabama Power Company's right-of-way in the Property predated the interest of plaintiff Kimberly D. Orsini ("Plaintiff") in the Property (see Exhibit D). Plaintiff acknowledges her ownership right in the Property is subject to the ownership rights of Alabama Power Company.

Defendant and former judgment creditor SMW Engineering Group, Inc. has no interest in the subject property as evidenced by the Satisfaction of Judgment it signed and recorded on July 1, 2014 in Instrument # LR20140702000199850 (see Exhibit E).

Given the foregoing, based upon its review of the pleadings, submissions and applicable law, this Court finds that full fee title to the Property is due to be and is hereby vested in Plaintiff Kimberly D. Orsini, who was substituted as plaintiff for the original plaintiff, First Commercial Bank, by order of this Court on October 28, 2014 (see Exhibit F). All matters in this matter have now been adjudicated fully and Plaintiff Kimberly D. Orsini is hereby ordered and declared to be the fee simple owner of the Property, subject however to (i) ad valorem taxes thereon, whether same are yet due and payable, and all prior recorded rights of way and easements in favor of defendant Alabama Power Company. Costs are taxed as paid.
