

**ARTICLES OF ORGANIZATION

The limited liability company is organized for the purpose of general contracting within residential construction, and for the purpose of transacting any lawful business for which a limited liability company may be organized.

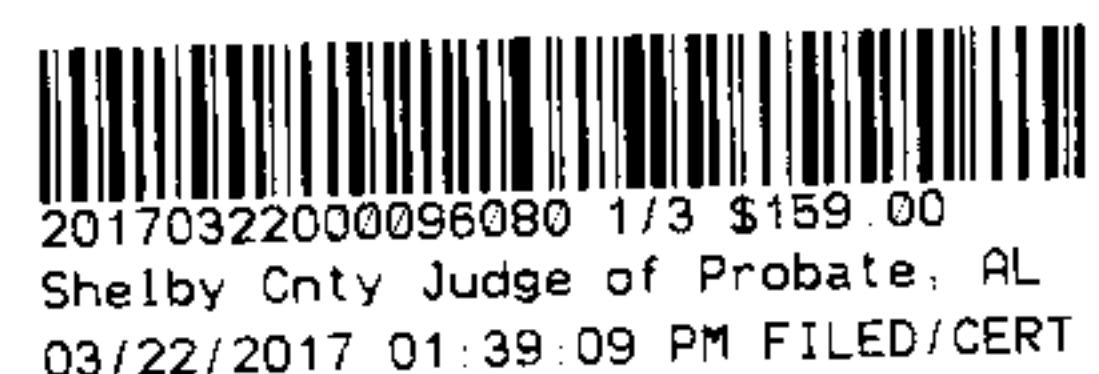
ARTICLE SEVEN
