KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three-hundred sixty thousand (\$360,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Riggins Parker and wife, Kim Parker (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto David Blake Hays and Megan Camp Hays (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 48, according to the Map and Survey of Sterling Gate, Sector 3, Phase 4, recorded in Map Book 34, Page 35, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

Three-hundred forty-two thousand (\$342,000.00) of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.


