### JEFFERSON AND SHELBY COUNTY PARCELS:

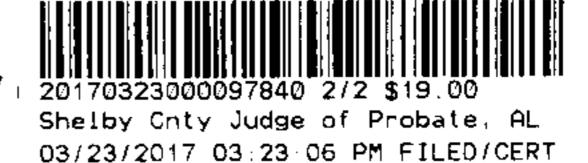
