**AMENDMENT TO
MEMORANDUM OF
SEWER SERVICE AGREEMENT
REGARDING
*THE NARROWS RESIDENTIAL SECTORS***

This **AMENDMENT TO MEMORANDUM OF SEWER SERVICE AGREEMENT REGARDING *THE NARROWS RESIDENTIAL SECTORS*** (the "Amendment") is made and entered into as of the 10th day of March, 2017 by **DOUBLE OAK WATER RECLAMATION, LLC**, an Alabama limited liability company ("DOWR").

On November 2, 2012, DOWR executed the **MEMORANDUM OF SEWER SERVICE AGREEMENT REGARDING *THE NARROWS RESIDENTIAL SECTORS*** (the "Memorandum") with regard to a Sewer Service Agreement ("SSA") entered into by and between **KOO, LLC**, an Alabama limited liability company ("Subscriber") and **DOWR** for the purpose of providing sanitary sewer service to all lots and parcels within **THE NARROWS RESIDENTIAL SECTORS** (the "Development"). The Development was legally described in **EXHIBIT A** attached thereto and made a part thereof.

WHEREAS, capitalized terms not otherwise defined herein shall have the meanings given to them in the Memorandum; and

WHEREAS, DOWR desires hereby to amend the Memorandum to delete certain property from **EXHIBIT A**.

NOW THEREFORE, in consideration of the premises, DOWR hereby states as follows:

1. The following property known as the Narrows Lakes Estates was mistakenly legally described as part of **EXHIBIT A** to the Memorandum:

NARROWS LAKE ESTATES:

The Narrows Lake Estates Sector, as recorded in **Map Book 35, Page 12.**

The Narrows Lake Estates Sector, as recorded in **Map Book 39, Page 117.**

Said Narrows Lake Estates Sectors are hereby deleted from **EXHIBIT A** to the Memorandum and the Memorandum shall have no force or effect with regard to the property situated within said Narrows Lake Estates Sectors.

2. Except as expressly amended by this Amendment, the Memorandum in its entirety shall remain in full force and effect.
