Know All Men by These Presents: That in consideration of **Two Hundred Fifteen Thousand and no/100 Dollars (\$215,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **FRANK D. CAGLE, III, a married man and PATRICIA L. CAGLE, a married woman** (herein referred to as Grantors) grant, bargain, sell and convey unto **CHARLES R. FRANKLIN and REGENA K. FRANKLIN** (herein referred to as Grantees), the following described real estate, situated in **Shelby County, Alabama**, to-wit:


