THAT IN CONSIDERATION OF **One Hundred Twelve Thousand Five Hundred and 00/100 Dollars (\$112,500.00)** and other good and valuable consideration to the undersigned Grantor in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **Robin Reed Mobley, as Trustee of the J. Steven Mobley Irrevocable Trust** (herein referred to as Grantor/Seller), does grant, bargain, sell and convey unto **Mobley Development, Inc.** (herein referred to as Grantee/Purchaser), an undivided one-half interest in and to the following described real estate situated in the State of Alabama, County of Shelby (the “Property”), to-wit:

- Subject to:
1. General and special taxes or assessments for 2017 and subsequent years not yet due and payable.
