

Articles of Organization for U Score Test Prep, LLC

To the Honorable Judge of Probate of Shelby County, Alabama

The undersigned, desiring to form a Limited Liability Company under the Limited Liability Company Act, adopt the following Articles of Organization for such Limited Liability Company:

1. The name of the Limited Liability Company shall be U Score Test Prep, LLC.
2. The period of duration of the Limited Liability Company shall be 25 years, unless dissolved according to Section 10-12-37 of the Alabama Code. Upon the death, resignation, incompetency, expulsion, or bankruptcy of a member, the remaining members shall have the right to unanimously agree, by written, consent within 90 days, to continue the duration of the Limited Liability Company provided there are at least 1 (one) remaining members. All members consent to the restriction and limitations as to admitting additional members and the right to sell, pledge, or otherwise convey their interest in the Limited Liability Company, as specified in the operation agreement.
3. The purpose for which the Limited Liability Company is organized is to transact any and all lawful business for which a Limited Liability Company may be organized under the State of Alabama including retail, wholesale sales, of industrial merchandise and supplies; purchase, construction, and leasing real property; purchasing and leasing of furnishings and equipment; financing activities of all types; and providing management and consulting services to the public, industrial and related industry.
4. The location of initial registered office of the company shall be 128 Total Solutions Way, Alabaster, AL 35007 and the name of the initial registered agent at that address is Peggy Adams.
5. No member can demand the distribution of cash or any other assets.
6. No member can bargain, sell, convey, or encumber their interest without the approval of all other members.
7. Extend the life of this agreement an additional 25 years from this agreement unless otherwise dissolved.

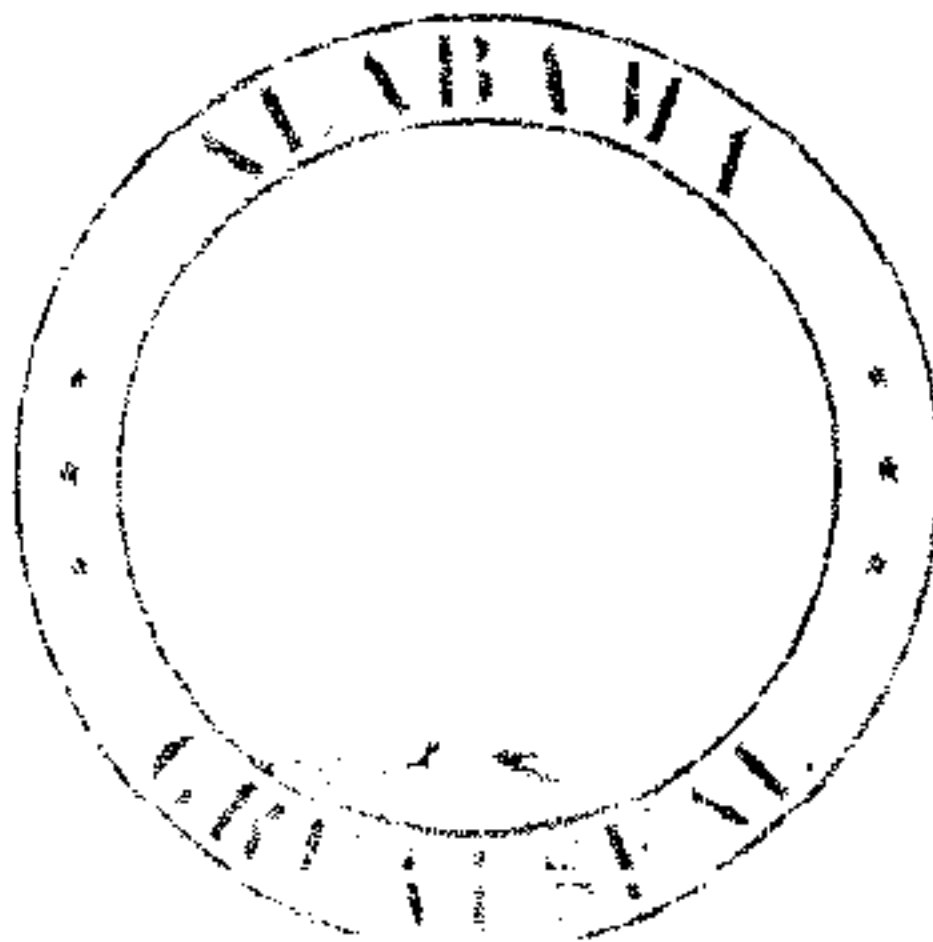
