That in consideration of the sum of **One Hundred Thirty Nine Thousand Nine Hundred Dollars and No Cents (\$139,900.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Lawrence Stanfield and Margaret Stanfield**, Husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Dwight A. 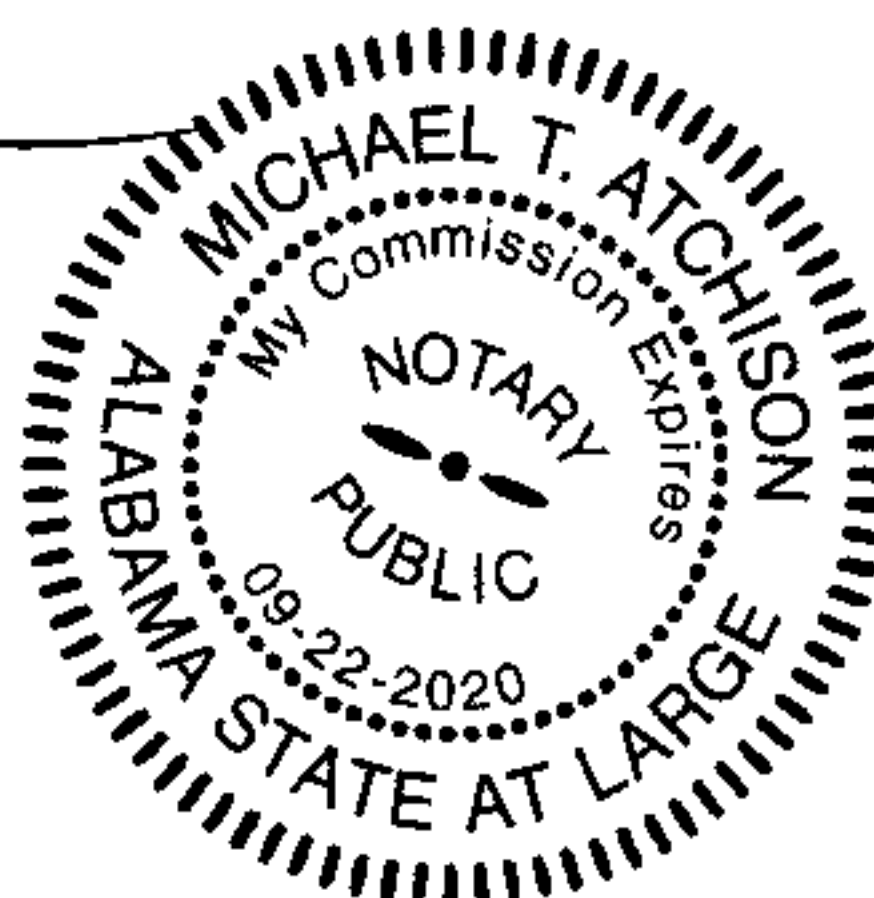
