THAT IN CONSIDERATION OF **One Hundred Sixteen Thousand Dollars and NO/100 (116,000.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Wesley Foster, Jr., a married person conveying property that is not his homestead nor that of his spouse**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Corey Wilkins and Victoria E.
