KNOW ALL MEN BY THESE PRESENTS, That in consideration of **Five Hundred Forty Five Thousand Four Hundred Seventy Eight Dollars and No Cents (\$545,478.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Harris Doyle Homes, Inc.** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Lucas B. Scoggin and Claudia Scoggin (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in **Jefferson County, Alabama, to-wit:** & Shelby County

Lot 20, according to the Survey of Altadena Ridge, as recorded in Map Book 244, Page 26, in the Probate Office of Jefferson County, Alabama and recorded in Map Book 47, Page 31, A & B, in the Probate Office of Shelby County, Alabama.

SUBJECT TO: (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any

Note: \$521,059.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

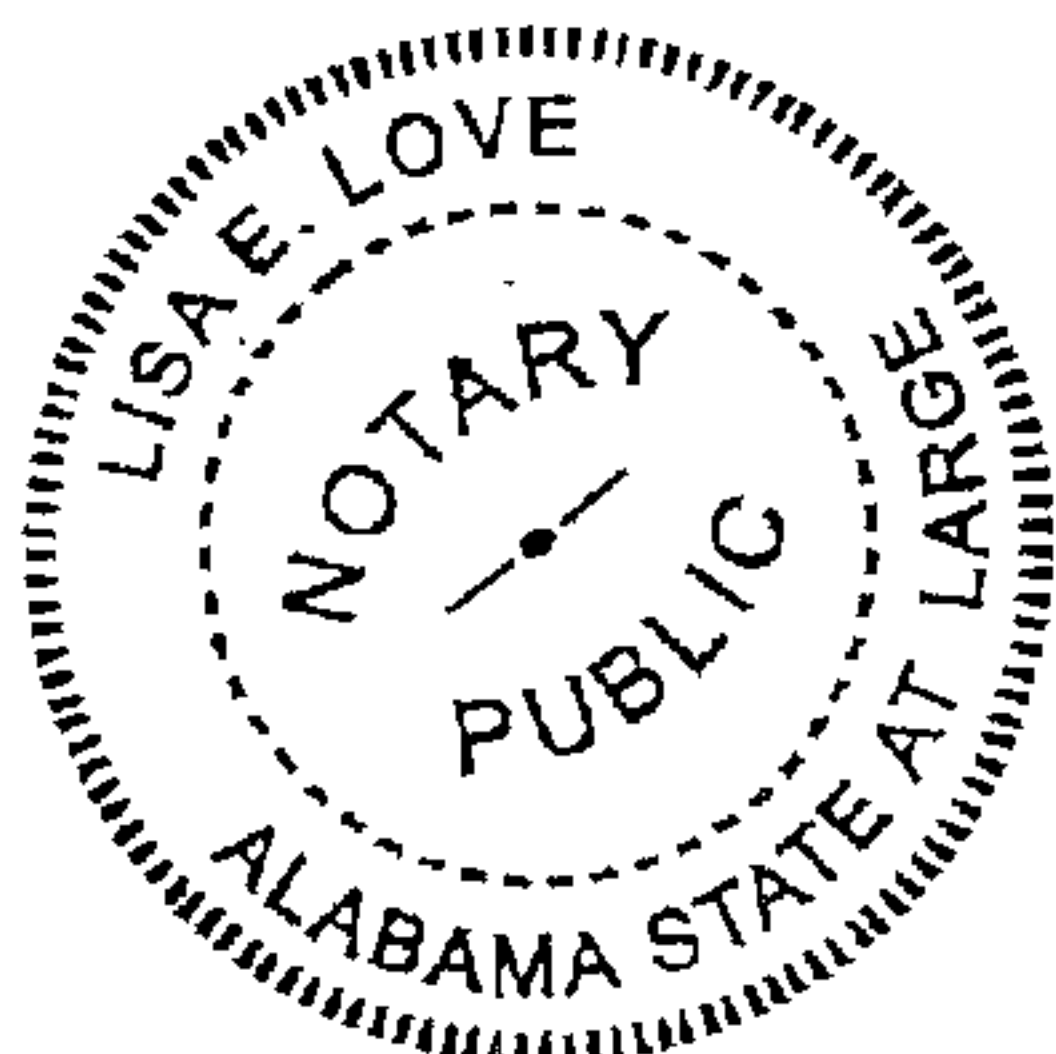
