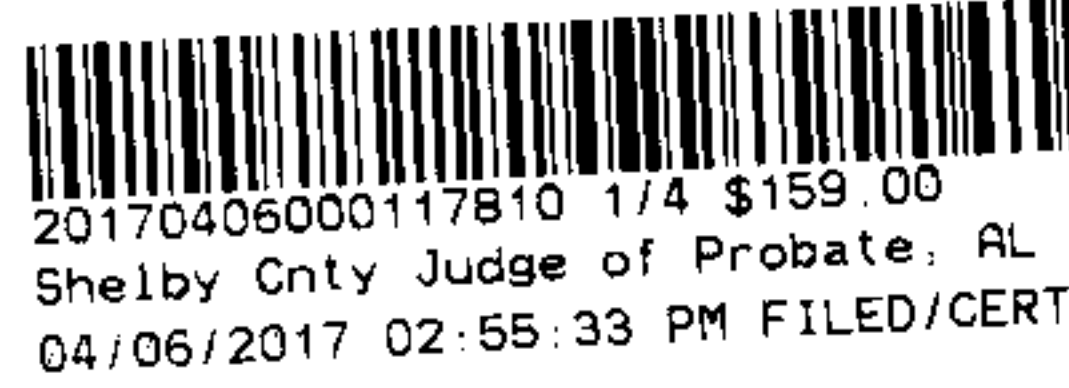

**CERTIFICATE OF FORMATION
OF
STRUT & RUT UNLIMITED, LLC,
an Alabama limited liability company**

Pursuant to the provisions of the Alabama Limited Liability Company Law of 2014, Section 10A-5A-1.01, *et seq.* of the Code of Alabama (1975, as amended) (the "Law"), the undersigned hereby adopts the following Limited Liability Company Certificate of Formation:

ARTICLE I

Name

The name of the limited liability company is **STRUT & RUT UNLIMITED, LLC** (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until perpetuity, unless it is dissolved and its affairs wound up prior to that date in accordance with the Law and/or the Company Agreement.

ARTICLE III

Purposes

The purposes for which the Company is formed are to own, manage, and operate a hunting and fishing retail store, but the Company may engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Law.

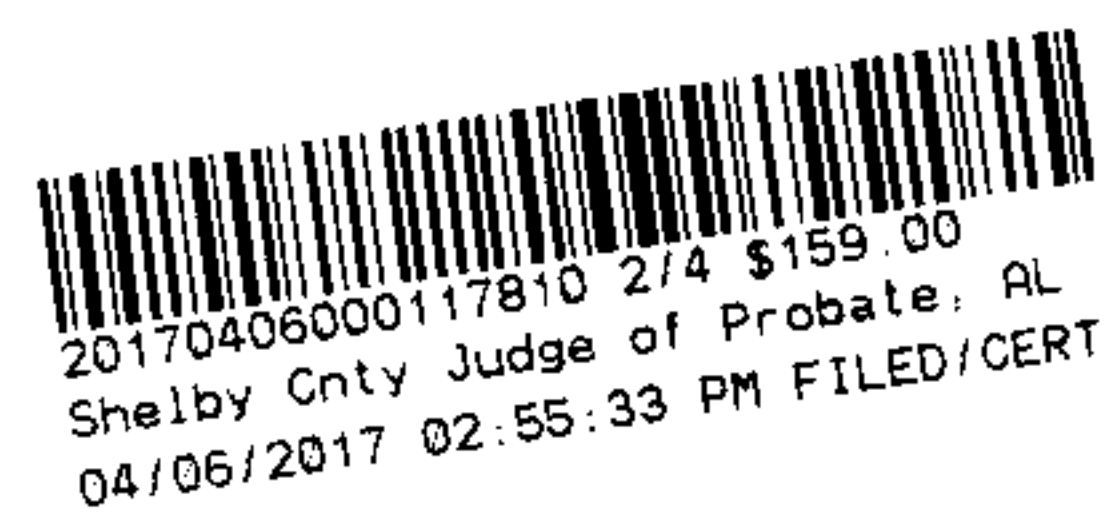
