All Debtor's right, title and interest in, to, and under any and all of the following described property (the "Property"), whether now owned or held or hereafter acquired:

- (a) All those certain tracts or parcels of land located in Jefferson County, Alabama, as more particularly described as Lot 68, according to the Map and Survey of Bent Creek Subdivision, Sector 2, Phase 2, as recorded in Map Book 45, Page 36, in the Probate Office of Shelby County, Alabama and
