WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Thirty-Five Thousand and 00/100 Dollars (\$235,000)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Wilbur L. Holaday, Jr. and his wife Elsa R. Holaday

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Benjamin Sawyer and Rebekah Sawyer

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

Lot 52, according to the Survey of Autumn Ridge, as recorded in Map Book 12, Pages 4, 5 and 6 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

\$230,743 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2017 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.






