WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Three Hundred Thirty Five Thousand Five Hundred and 00/100 Dollars (\$335,500.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Derek A. Dean and Koral M. Dean

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 53, according to the Survey of Amended Map of The Highlands 1st Sector, as the same is recorded in Map Book 19, Page 132, in the Probate Office of Shelby County, Alabama.

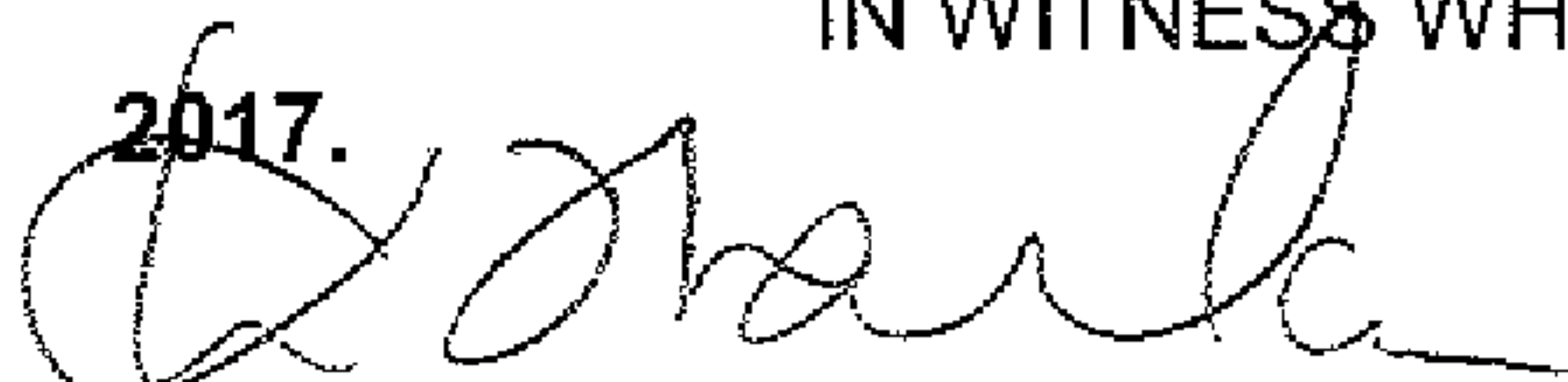
\$318,725.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2017 ad valorem taxes not yet due and payable;

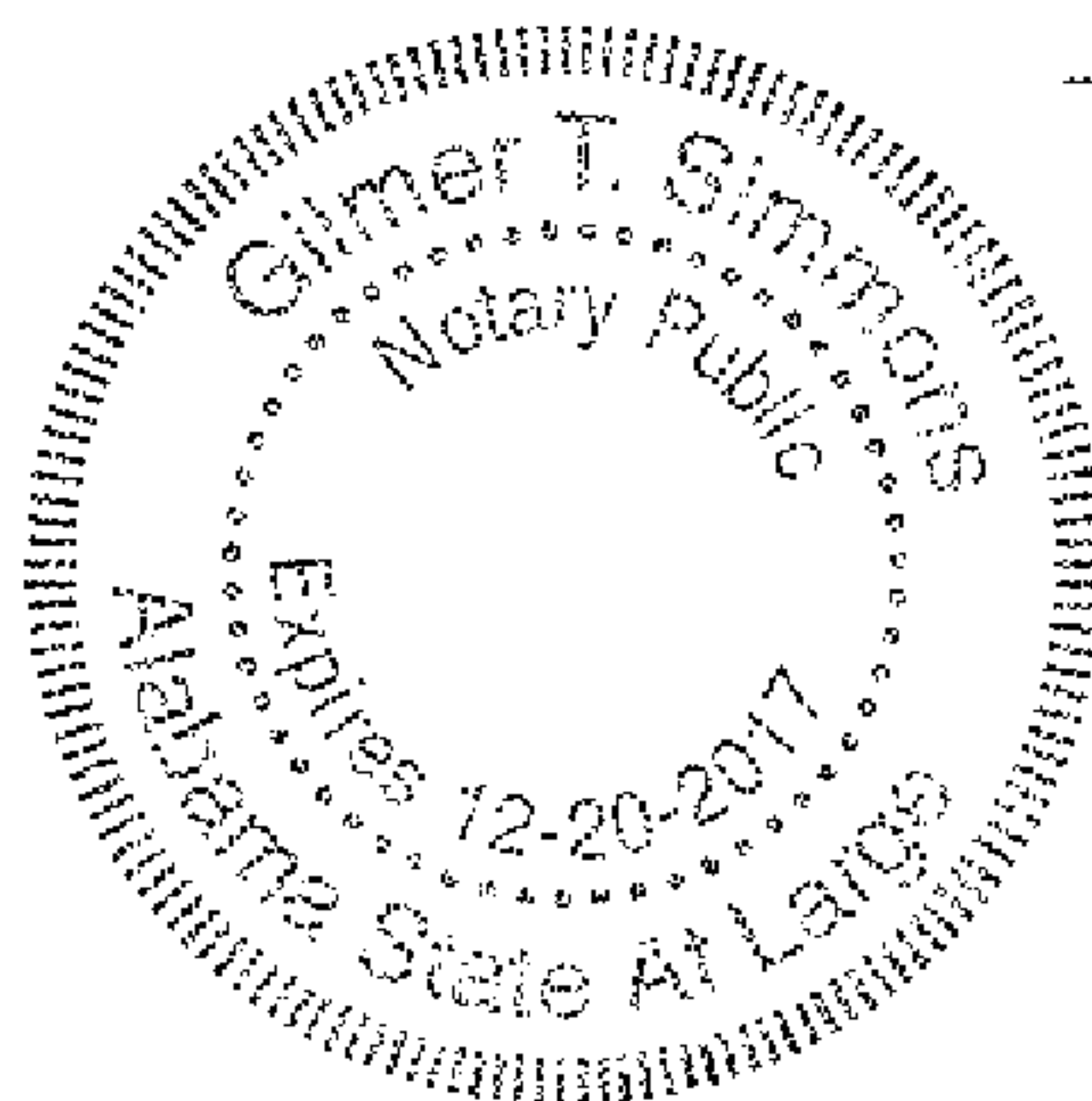

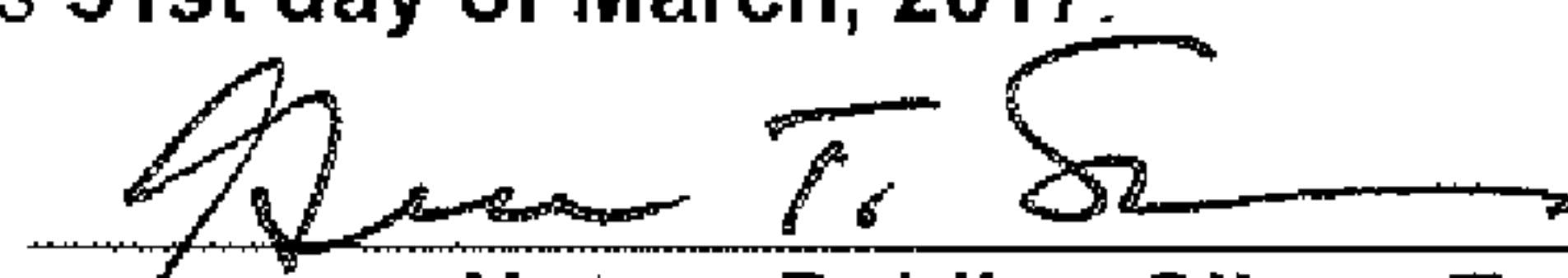

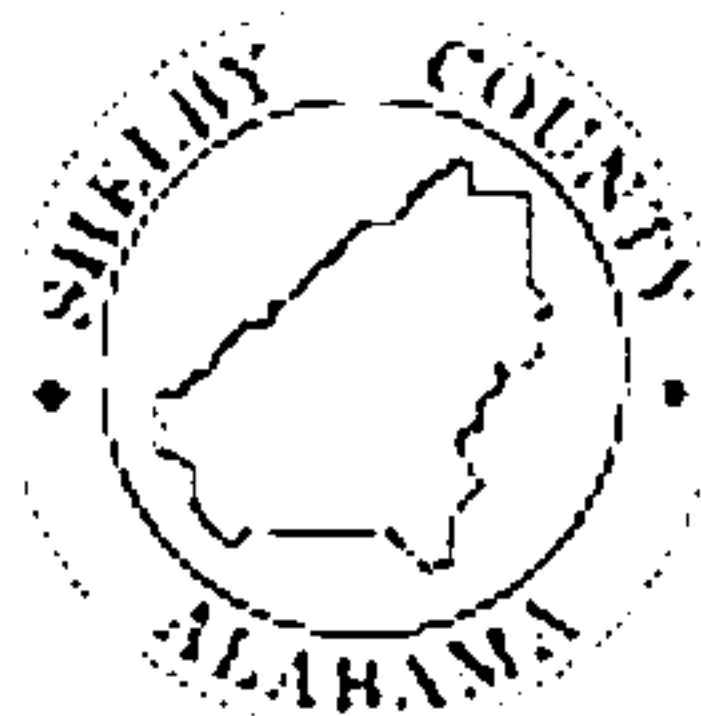
