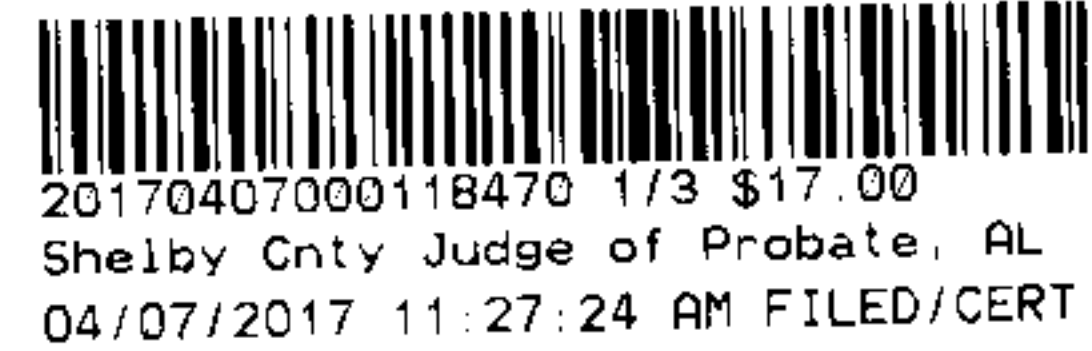

CERTIFICATE OF TRUST

The undersigned Grantors and Trustees hereby certify that a Revocable Living Trust, which is known as:

The John L. Schliesser and Lucy E. Schliesser Revocable Living Trust

U/D/T April 22, 1998

was formed on the date stated above. John L. Schliesser and Lucy E. Schliesser (therein referred to as "Grantors"), and John L. Schliesser and Lucy E. Schliesser (therein referred to as "Trustees"), have an address of 3544 Shandwick Place, Hoover, Alabama 35242.

IT IS AGREED BETWEEN THE PARTIES HERETO THAT THE FOLLOWING IS A CORRECT DESCRIPTION OF SAID TRUST:

The parties hereto desire to confirm the establishment of a Revocable Trust on the date stated above, for the benefit of the Grantors and containing the following provisions:

1. John L. Schliesser and Lucy E. Schliesser are designated as the Trustees to serve until they are unable or unwilling to serve as such Trustees.

2. Upon the end of the term of the original Trustees, the following will act as alternate Trustees in the following order: Jill Anne Watkins, then Karen E. Holley. A process for selecting a corporate alternate is included in the terms of the trust agreement if one is required. Any alternate Trustee shall serve as Trustee until she or it is unable or unwilling to serve as such Trustee.

3. The Trustee has the power and authority to manage, control, buy, sell, and transfer the Trust property in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights concerning said property and proceeds thereof as fully and amply as though said Trustee were the absolute and qualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments, except to the extent that such management would cause the inclusion of an irrevocable trust in the Estate of a Trustee, which would otherwise not be so included.

4. Following the death of John L. Schliesser and Lucy E. Schliesser, the Trust shall either continue or be distributed in whole or in part for the benefit of other named Beneficiaries according to the terms of the Trust.

5. While the Grantor is living and competent, except when there shall be a Corporate Trustee, the Grantor/Trustee may add assets to or withdraw assets from any bank or savings and loan or checking account owned by the Trust without the approval of any alternate Trustee.

6. Unless indicated to any prospective transferee, the Trustee has full power to transfer assets held in the name of the Trust and subsequent transferees are entitled to rely on such transfers provided the chain of title is not otherwise deficient.

7. The Trust Agreement also states that any bank, corporation, brokerage firm or other entity or any individual may conclusively presume that the Trustee has full power and authority, and such person or institution shall be held harmless and shall incur no liability by reason of so presuming.

8. The situs of the Trust is the State of Alabama.

9. The use of this Certificate of Trust is for convenience only and the Trust solely controls as to provisions and interpretations, and any conflict between this Certificate of Trust and the Trust shall be decided in favor of the Trust.
