

MODIFICATION OF MORTGAGE

Notice: The original principal amount available under the Note (as defined below), which was \$10,200.00 (on which any required taxes already have been paid), now is increased by an additional \$54,800.00.

THIS MODIFICATION OF MORTGAGE dated March 23, 2017, is made and executed between Mike Kelley; Sandra Kelley, Husband and Wife and Denise Graham, an unmarried woman (referred to below as "Grantor") and Central State Bank, whose address is P O Box 180, Calera, AL 35040 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated March 23, 2017 (the "Mortgage") which has been recorded in Shelby County, State of Alabama, as follows:

MODIFICATION. Lander and Grantor hereby modify the Mortgage as follows:

Increase Mortgage to Seventy Thousand Dollars and xx/100 (\$75,000.00).

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lander's right to require strict performance of the Mortgage as changed above nor obligate Lander to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lander to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lander that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
