OFFICE OF SHELBY COUNTY, ALABAMA.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.





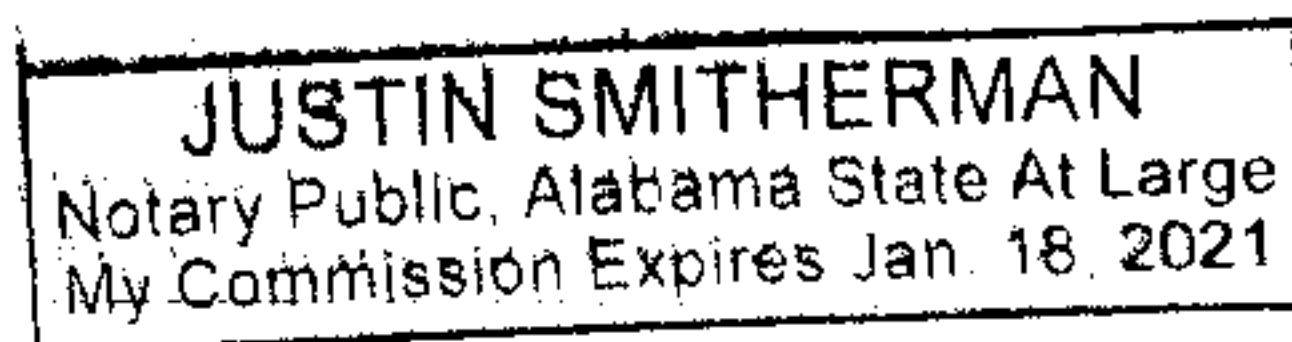
