Existing covenants and restrictions, easements, building lines and limitations of record.

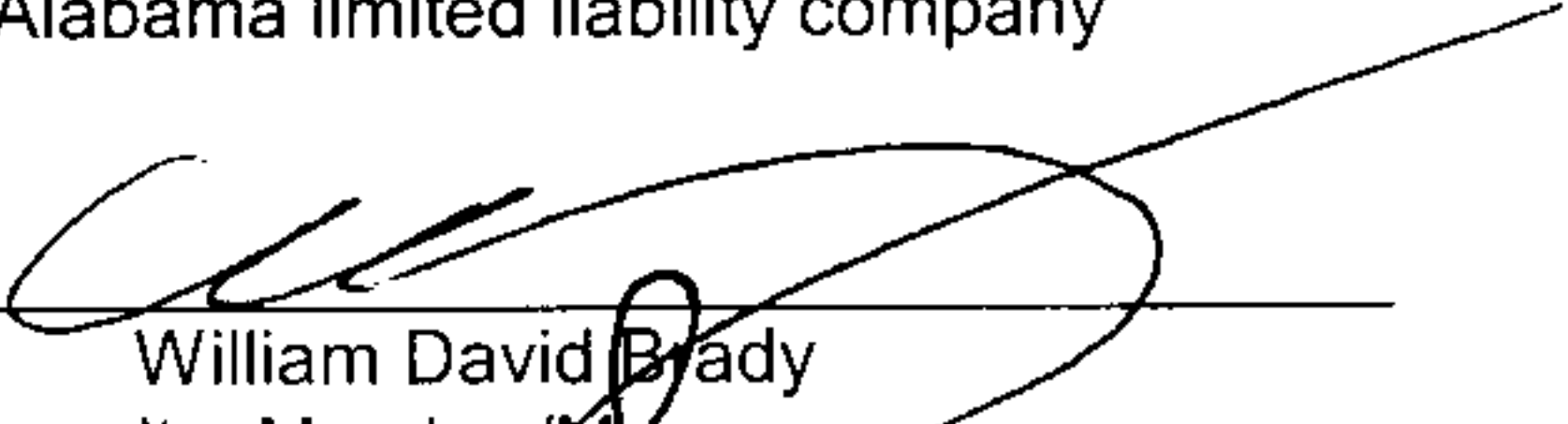
