**CORPORATION WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of **Two Hundred Nineteen Thousand Dollars and No Cents (\$219,000.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Harris Doyle Homes, Inc.** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Sunnie W. Stanley and David Stanley (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama, to-wit:

Lot 187, according to the Survey of Lacey's Grove Phase 2, as recorded in Map Book 38, Page 19, in the Probate Office of Shelby County, Alabama.

**SUBJECT TO:** (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any

Note: \$200,549.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

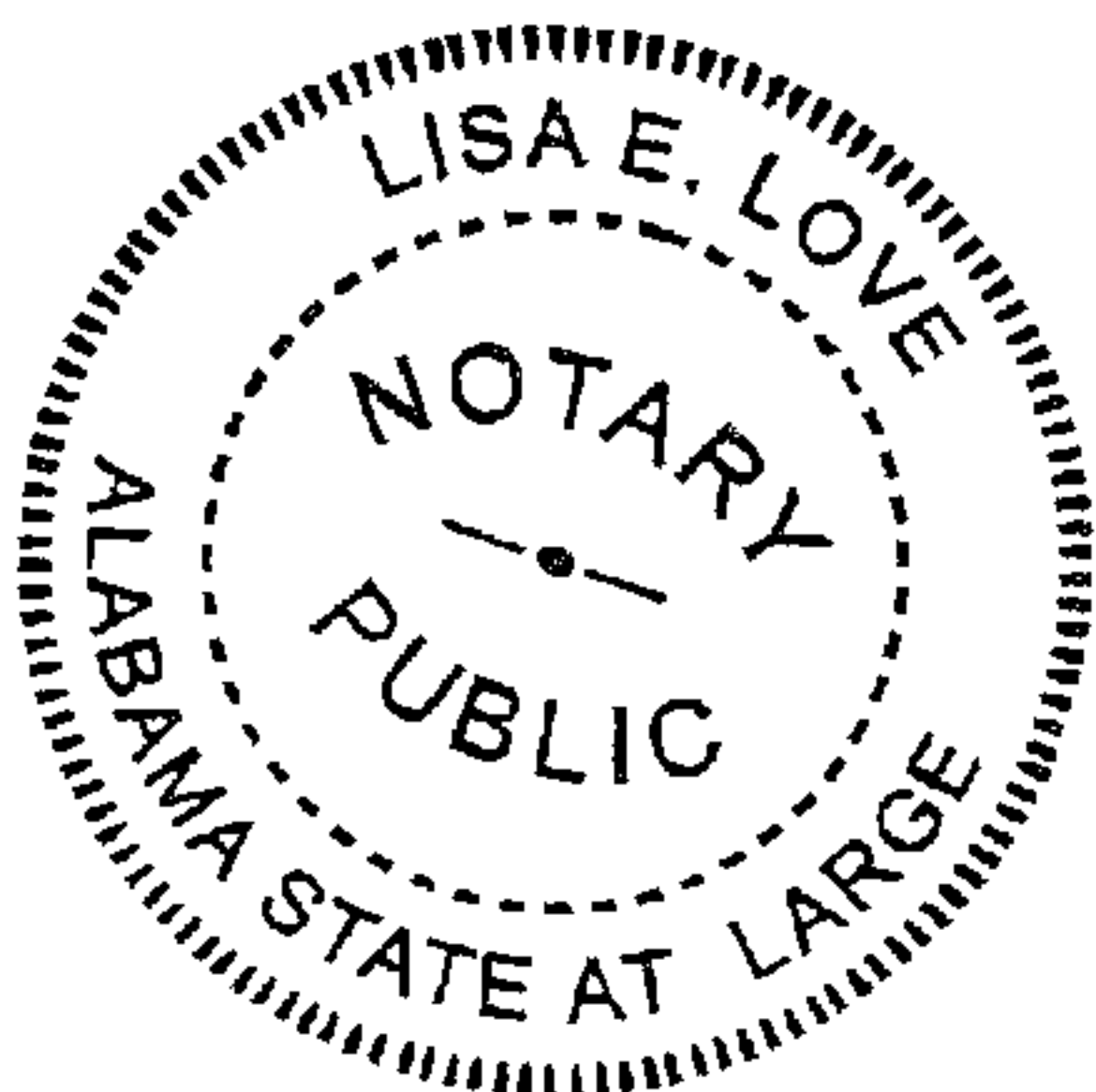



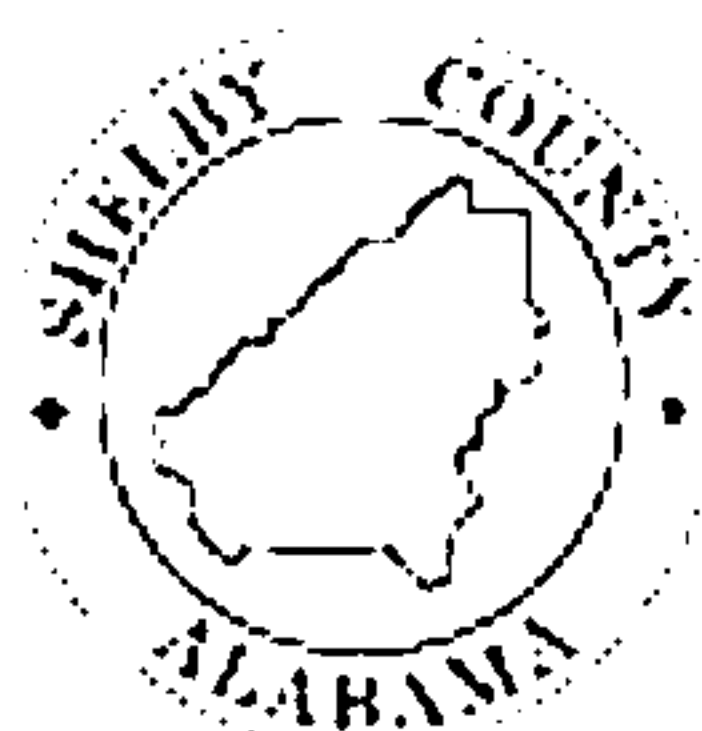
