KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of FOUR HUNDRED EIGHT THOUSAND FOUR HUNDRED NINETY THREE and NO/100 (\$408,493.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Trademark Engineering Services, Inc., an Alabama Corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Ronne Drew Stone and Jo Ann Stone** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:



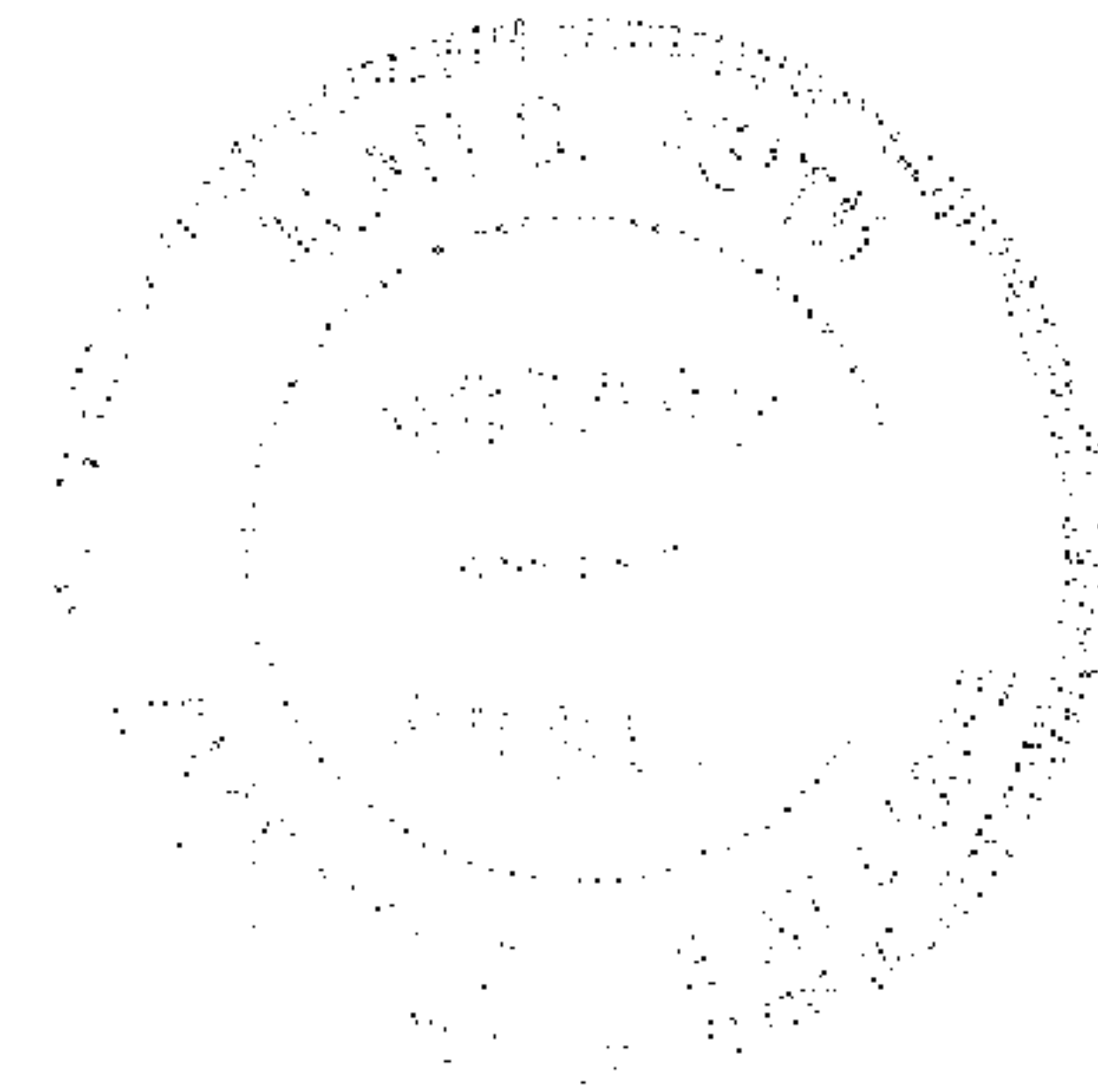

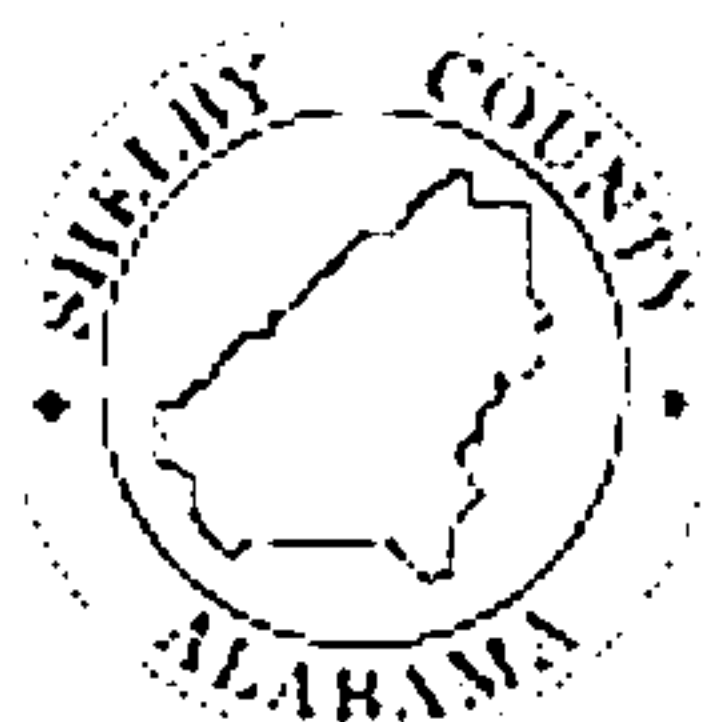
