The Myra Jo Gingo Family Trust, dated May 26, 2010.

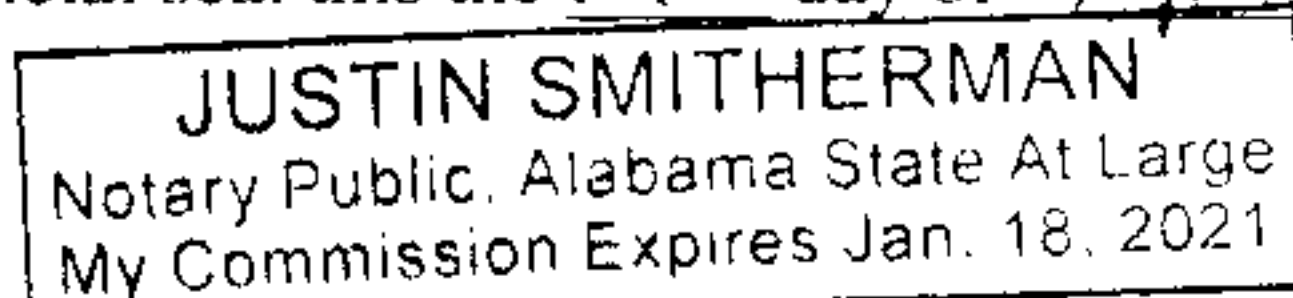
