Increase Loan to Twenty Thousand Nine Hundred Twenty Five Dollars and xx/10 (\$20,925.00).

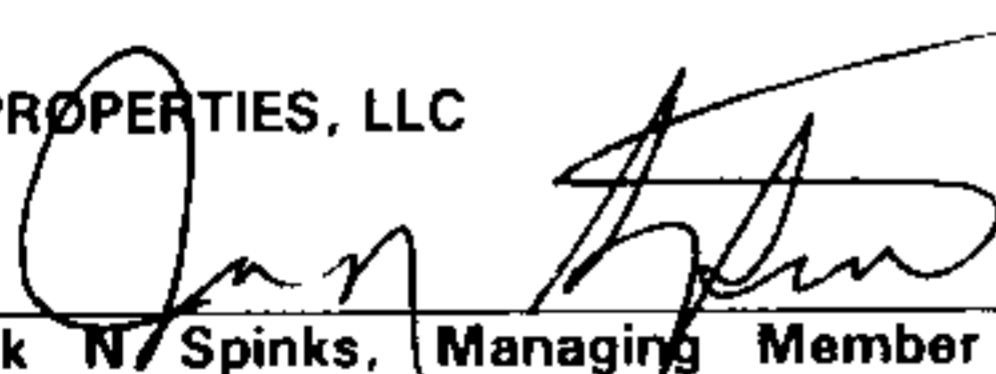
