

FULL RELEASE OF ALL SOCIÉTÉ GÉNÉRALE'S
LIENS AND ENCUMBRANCES ON REAL PROPERTY
AND OTHER COLLATERAL IN
SHELBY COUNTY, ALABAMA
[FIRST LIEN]

THIS RELEASE OF LIEN (the “**Release**”) is made and entered into by and between in the case of Non-Federal Collateral, Société Générale (the “**First Lien Agent/Non-Federal**”) and in the case of Federal Collateral, Société Générale Financial Corporation (the “**First Lien Agent/Federal**”), (collectively, the “**First Lien Agent**”) whose address is 1111 Bagby Street, Suite 2020, Houston, Texas 77002, and **SAGA RESOURCE PARTNERS LLC**, whose address is 600 17th Street, Suite 1700N, Denver, Colorado 80202 (the “**Mortgagor**”). **NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the First Lien Agent hereby releases, extinguishes, quit-claims and forever terminates any and all liens, encumbrances, security interests, mortgages, deeds of trust and all other recorded instruments now held by the First Lien Agent, however created or evidenced, to secure loans to Saga Resource Partners LLC (the “**Mortgagor**”) on the oil and gas leases and lands as more particularly described in the Mortgage, as recorded in Shelby County, Alabama as set forth below and all other properties, interests and other assets, covered by, described in, or pledged by the Mortgagor under that certain Mortgage, Security Agreement, Financing Statement, Fixture Filing and Assignment of Production dated effective as of June 14, 2013 and recorded on June 24, 2013 with the Office of the Probate Judge in and for the County of Shelby, State of Alabama, Number 20130624000257670 (as amended, the “**Mortgage**”), granted and conveyed by the Mortgagor unto the First Lien Agent in its capacity as the administrative agent under the Credit Agreement (as defined in the Mortgage) and on behalf of the Credit Parties (as defined in the Mortgage). The First Lien Agent hereby expressly releases the properties covered by the Mortgage from the liens and security interests created thereunder or under any other instrument, contract or agreement, now held by the First Lien Agent, however created or evidenced, including all liens and security interests carried forward or extended by any one or more of the Mortgage or any other security instrument executed by Mortgagor in favor of the First Lien Agent with respect to the properties covered by the Mortgage.

The First Lien Agent further agrees that the Mortgagor or its designee is authorized to file terminations of the financing statements set forth on the attached filing schedule as **Exhibit A** hereto in the records of the appropriate jurisdictions.

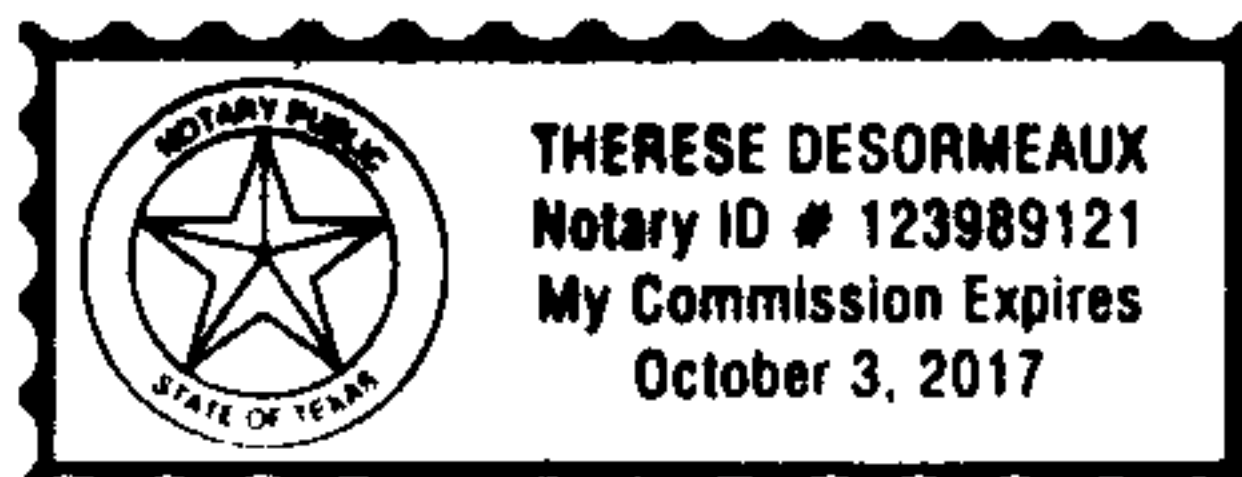
