

WHEREAS, pursuant to the terms, conditions, covenants, and provisions set forth in that certain Exploration Drilling Agreement dated April 20 , 2011 (the "Agreement") by and between Grantor and Jesse Creek, Grantor has granted to Jesse Creek the right to enter onto real estate more particularly described on Exhibit "A" attached hereto and made a part hereof (the "Property"); and		
WHEREAS, Grantor and Jesse Creek desire to enter into and record this Memorandum in order that third parties may have notice of the Agreement and Jesse Creek's interest and rights under the Agreement.		
NOW, THEREFORE, for and in consideration of the mutual covenants and agreements hereinafter contained, and the performance thereof by the parties hereto, the parties hereto hereby agree as follows:		
1. Term. Subject to the terms and conditions as further set forth in the Agreement, Jesse Creek shall have the right to enter the Property for a period of one (1) year from the date of the Agreement.		
2. <u>Post Term Rights</u> . Notwithstanding any termination or expiration of the Agreement, Jesse Creek shall retain the right to enter onto the Property to perform any repairs or reclamation to the Property required by applicable legal or regulatory requirements or the terms of the Agreement.		
3. <u>Right of First Refusal</u> . For a period of two (2) years from the date of the Agreement, Grantor shall not sell, lease, transfer, assign or otherwise convey, in whole or part, the Property or any interest therein without first offering the Property or the applicable part thereof or interest therein to Jesse Creek., as more fully set forth in the Agreement.		
4. <u>Conflicts</u> . All terms, conditions, provisions and covenants of the Agreement are incorporated in this Memorandum by reference as though fully set forth herein. Nothing contained herein shall be deemed or construed to amend, modify, change, alter, amplify, interpret or supersede any of the terms and provisions of the Agreement. In the event of a conflict between the terms of the Agreement and the terms of this Memorandum, the terms of the Agreement shall control.		

Counterparts. This Memorandum may be executed in any number of counterparts, each of

which shall be deemed to be an original and all of which, when taken together, shall constitute one and the

same agreement. For recording purposes, the executed counterparts shall be combined into a single instrument.


