Hirtle (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 1935, according to the map and survey of Dunrobin, at Ballantrae, Phase III, as recorded in Map Book 43, Page 118, in the Probate Office of Shelby County, Alabama.


