Know All Men by These Presents: That in consideration of **TEN AND NO/100 DOLLARS (\$10.00)** to the undersigned Grantor (whether one or more), in hand paid by the Grantees herein, the receipt of which is acknowledged, I, Judy Hasting Hyde, Trustee of Judy Hasting Hyde Revocable Trust, dated January 23, 2017 (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto Robert F Newsom and Betsy M Newsom, a married husband and wife, (herein referred to as Grantees), the following described real estate, situated in Shelby County, Alabama, to-wit:
