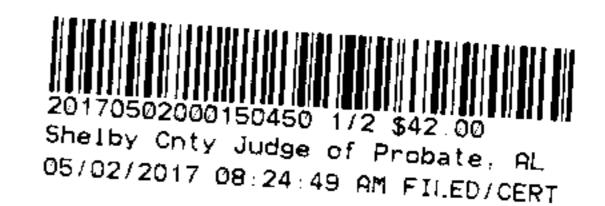
WARRANTY DEED

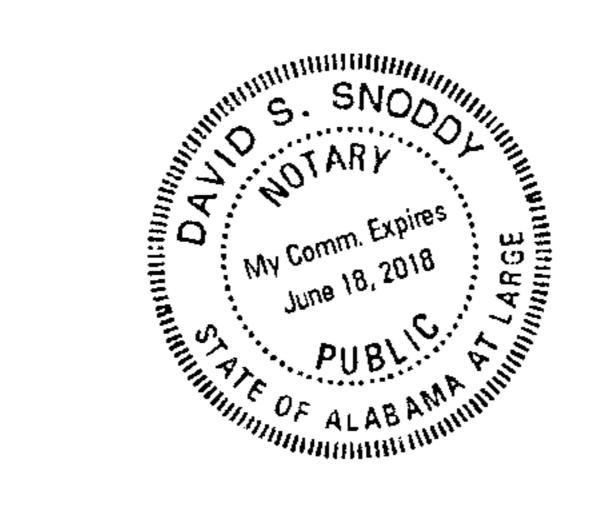
