GENERAL WARRANTY DEED
With Right of Survivorship

COUNTY OF SHELBY & JEFFERSON } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Two Hundred Fifty-four Thousand Nine Hundred Dollars and NO/100 (\$254,900.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Rodney Harbin, Jr., a married person**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **Alexandre Siqueira and Kate Siqueira** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY & JEFFERSON** County, Alabama to wit:

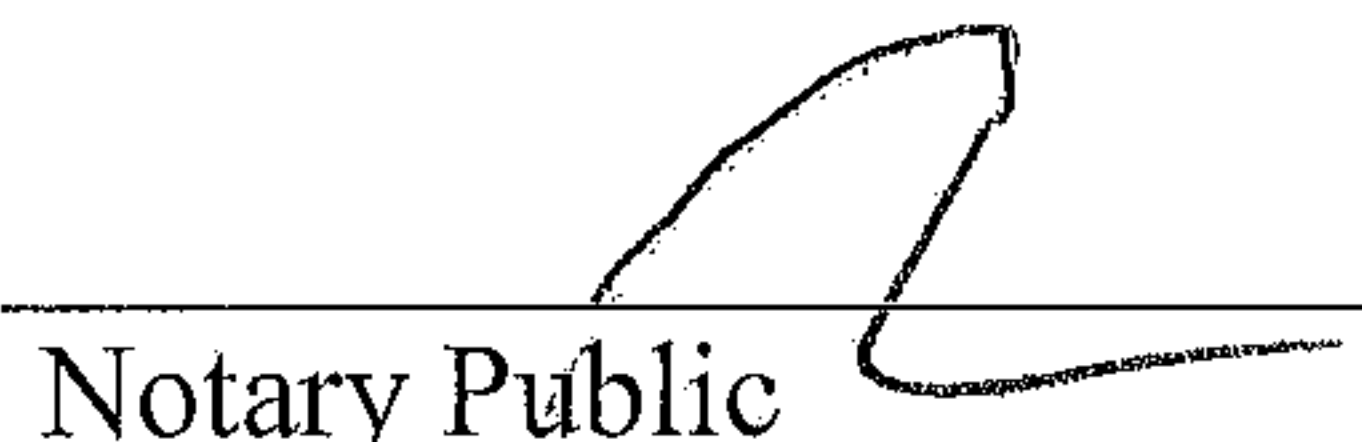

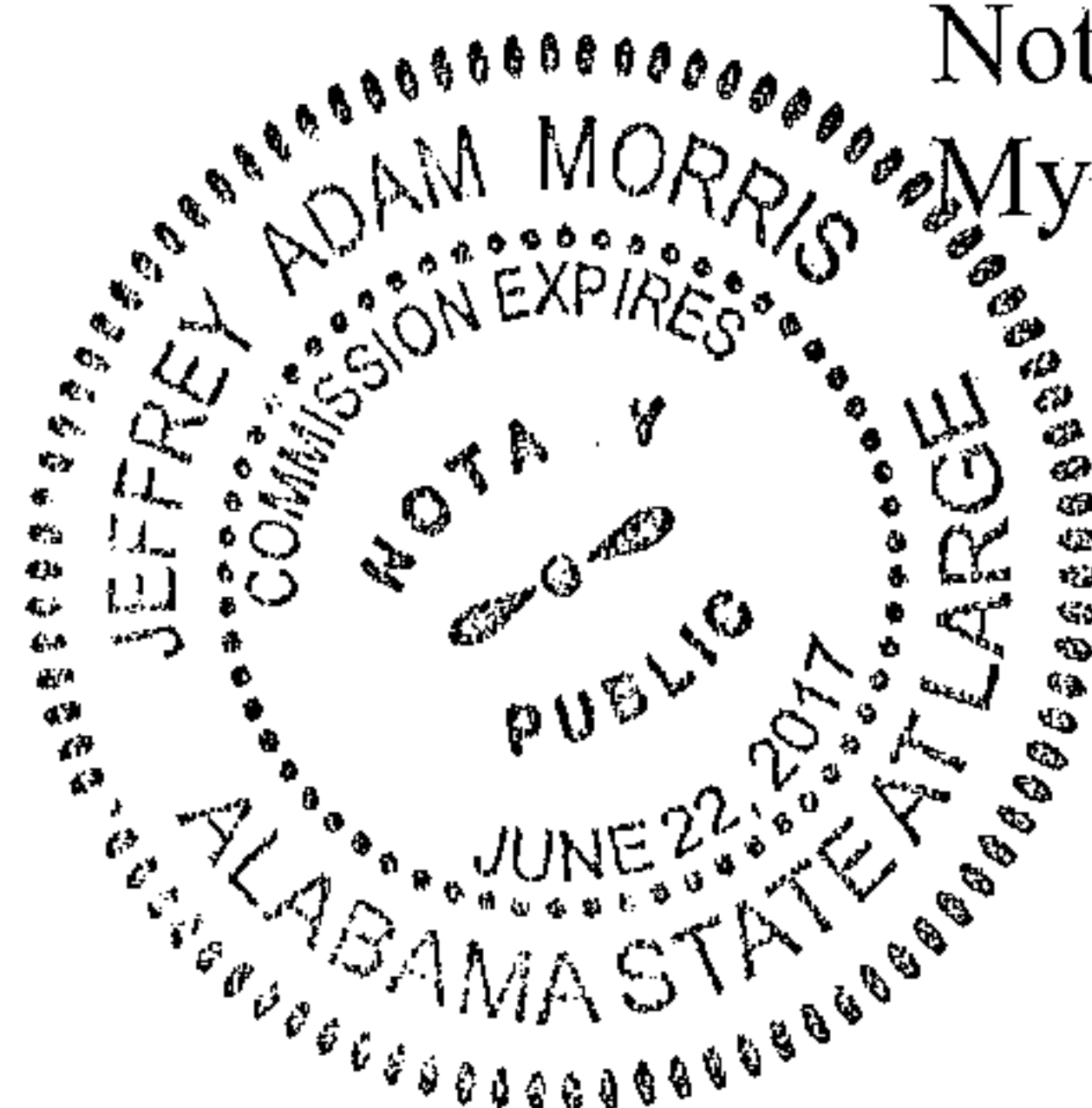
