**MORTGAGE FORECLOSURE DEED**

**KNOW ALL MEN BY THESE PRESENTS, That:**

WHEREAS, heretofore, on to-wit, September 25, 2014, **Virgil E. Ingram, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Suntrust Mortgage, Inc.**, which said mortgage is recorded in Instrument No. 20141008000317450, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **SunTrust Mortgage, Inc.**, as transferee, said transfer is recorded in Instrument 20170113000018520, aforesaid records, and SunTrust Mortgage, Inc., is now the holder and owner of said mortgage and debt; and

WHEREAS, on April 20, 2017, the day on which the foreclosure sale was due to be held under the terms of said notice at 12:03 o'clock am/pm between the legal hours of sale, said foreclosure was duly and properly conducted and SunTrust Mortgage, Inc. did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Pelham, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of SunTrust Mortgage, Inc. in the amount of **ONE HUNDRED TWENTY-FIVE THOUSAND FOUR HUNDRED DOLLARS AND NO CENTS (\$125,400.00)** which sum the said SunTrust Mortgage, Inc. offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said SunTrust Mortgage, Inc.; and




