Subject to easements, restrictions, covenants, conditions, rights of way, and encumbrances of record.



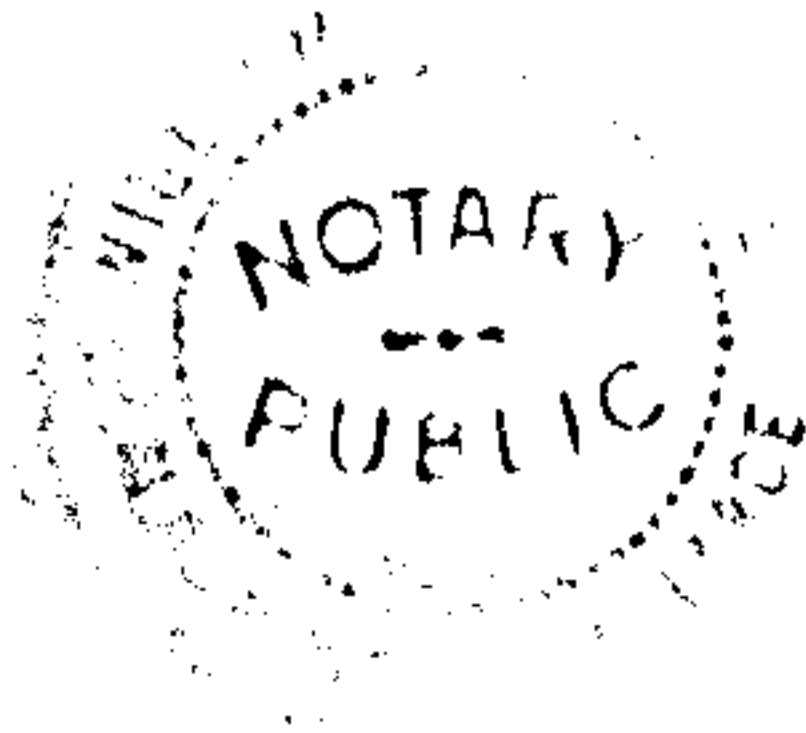
