WHEREAS, heretofore on 04/06/12, James R. Bennett and Andrea B. 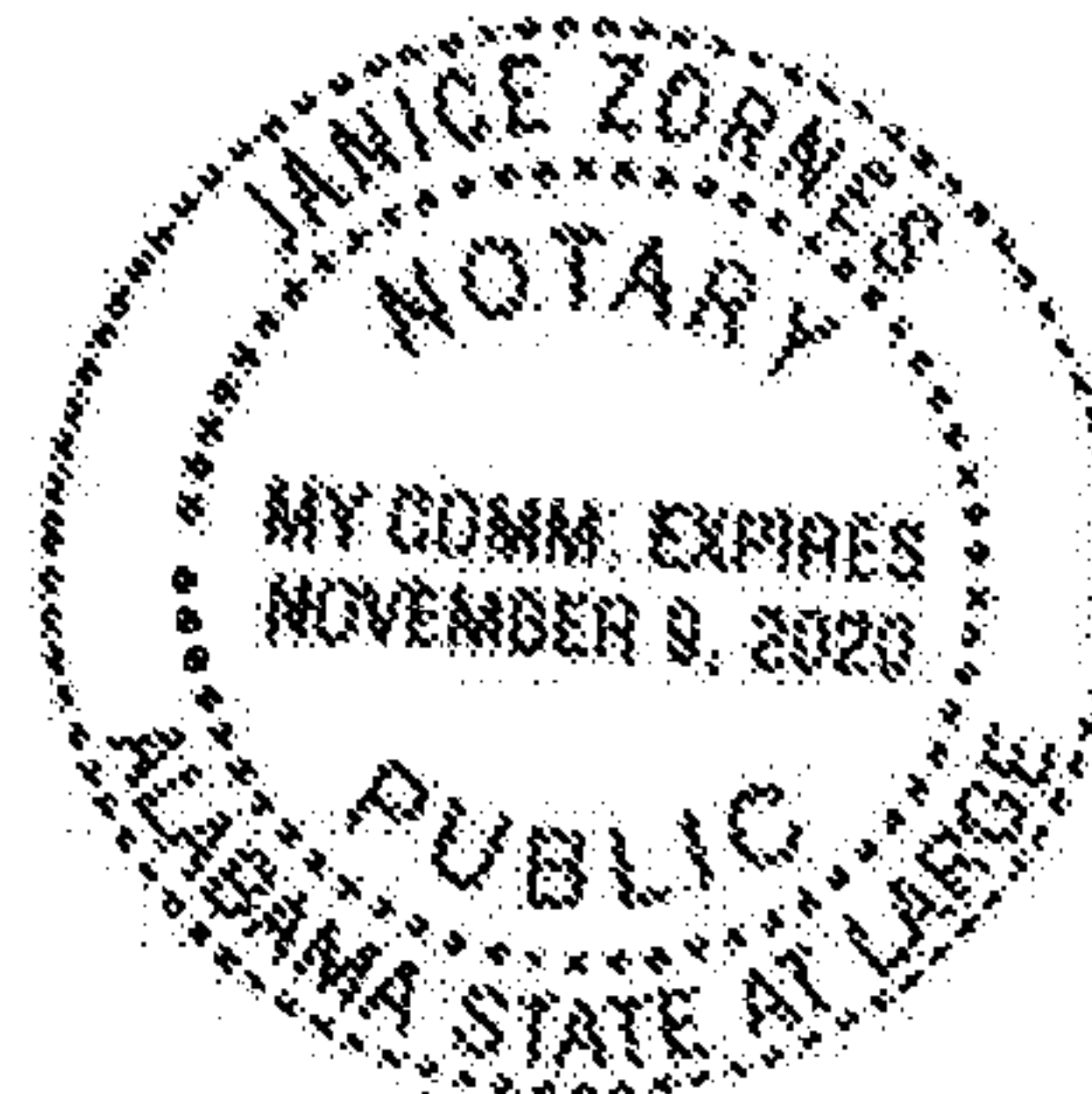
