KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Fifty Nine Thousand and 00/100 Dollars (\$259,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Stephen L. Gutshall and Greta F. Gutshall

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 48, according to the Survey of Third Addition Riverchase West, as recorded in Map Book 7, Page 139, in the Probate Office of Shelby County, Alabama.

\$254,308.00 of the proceeds come from a mortgage recorded simultaneously herewith.

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

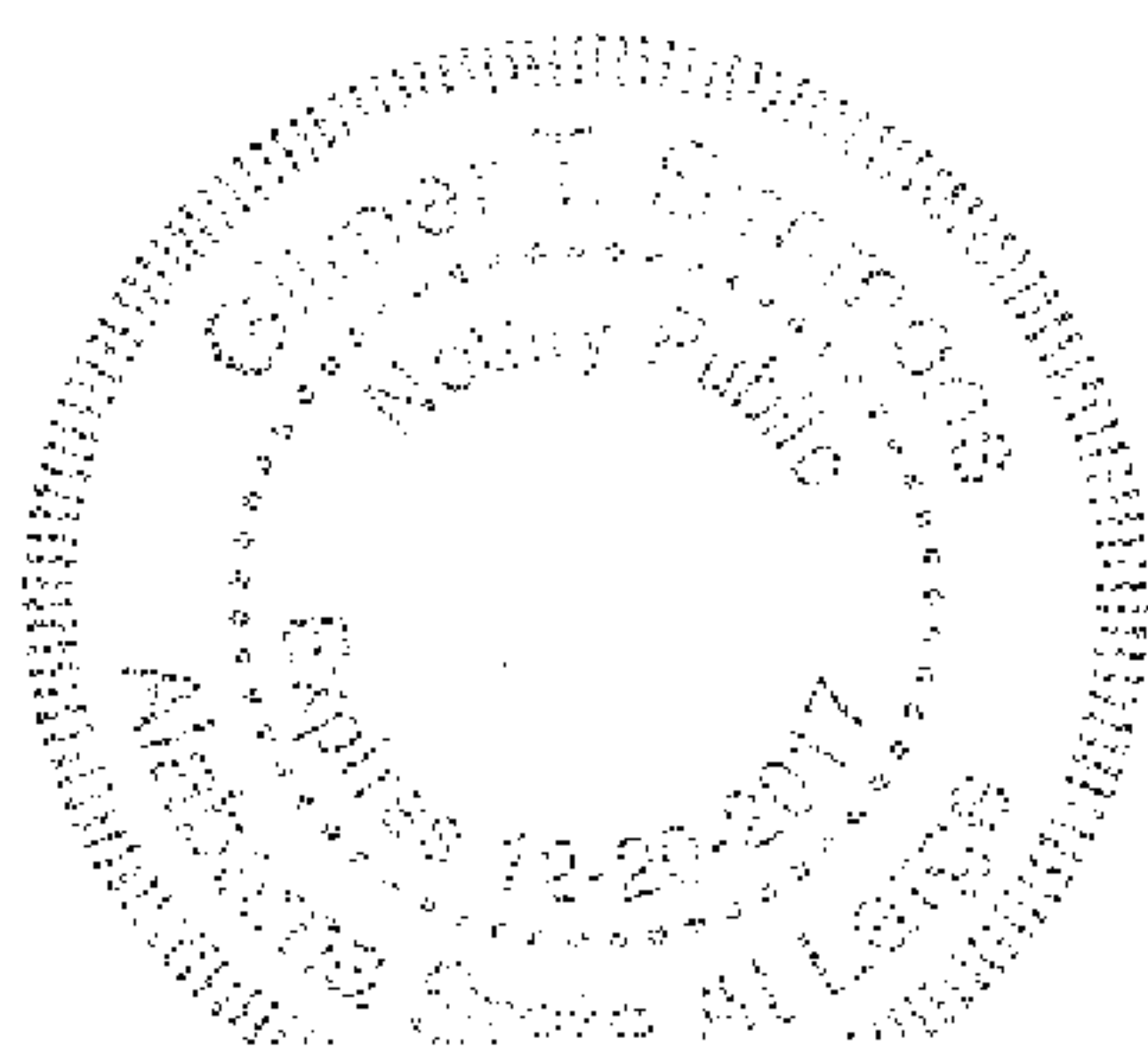
