Griffin (herein referred to as GRANTOR, whether one or more) do grant, bargain, sell and convey unto Johnathan Alex Moore (herein referred to as GRANTEE) all of their right, title, and interest in and to the following described real estate situated in Shelby County, Alabama to-wit:

A part of the Northwest quarter of the Southeast quarter of Section 33, Township 19 South, Range 1 West, more particularly described as follows:
