

**ARTICLES OF ORGANIZATION**  
**OF**  
**HOUSE OF BLESSINGS AT SUNNYSIDE, LLC**

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter referred to as "the Act"), the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

**ARTICLE I**

**NAME**

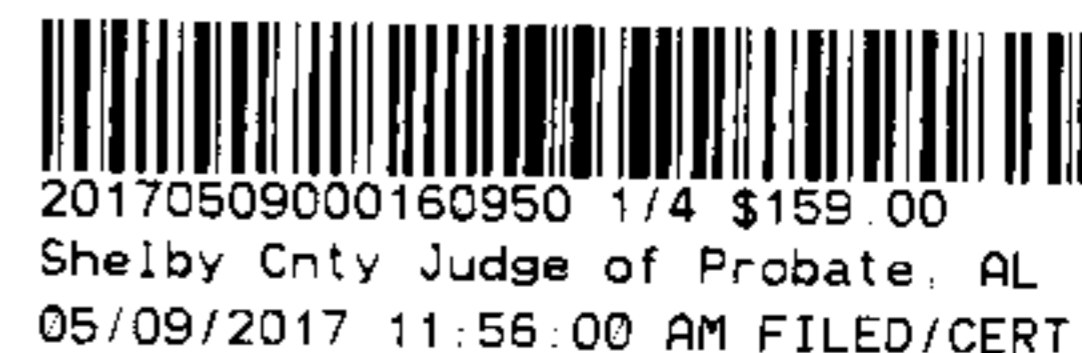
The name of the limited liability company ("Company") is House of Blessings at Sunnyside, LLC.

**ARTICLE II**

**DURATION**

The period of duration for the Company shall be from the date of filing these Articles of Organization with the Office of the Judge of Probate of Shelby County, Alabama (the "Filing Date"), until the earliest to occur of the following:

- A. The fiftieth (50th) anniversary of the Filing Date;
- B. Dissolution of the Company by the unanimous written agreement of the Members; or
- C. The occurrence of an event which under the Act constitutes an event of dissolution or otherwise works a termination of the Company under the Act, unless the legal existence and business of the Company are continued pursuant to Article VII below.



**ARTICLE III**

**PURPOSES**

The Company has been organized for the following purposes:

- (1) to engage in assisted living and residential care of the elderly; to purchase, take, receive, lease or otherwise acquire, own, hold, improve, develop, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to manage, market, sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein; and to engage in any and all business activities related to or incidental thereto;
- (2) For any lawful purpose or purposes for which a limited liability company may be organized under the laws of the State of Alabama.

**ARTICLE IV**

**INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

The location and mailing address of the initial registered office of the Company is 6547 Mill Creek Circle, Birmingham, Alabama 35242 and the name of the initial registered agent of the Company at such address is Emese Gloria Eremity

**ARTICLE V**

**SOLE MEMBER**

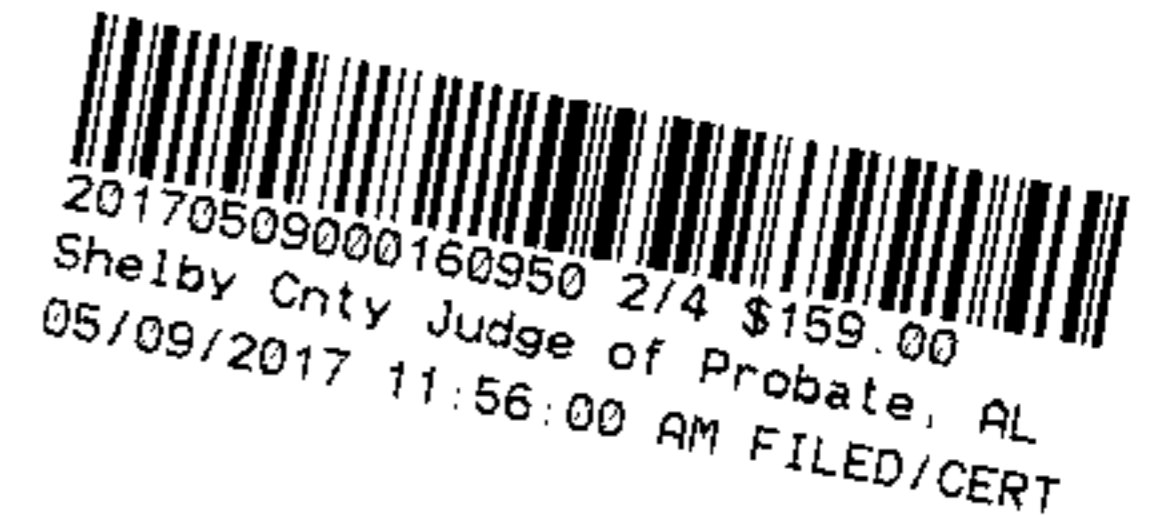

**ARTICLE VI**

**ADMISSION OF NEW MEMBERS**

The sole member of the Company shall have the right to admit new members from time



to time. In the event the sole member has admitted new members, any additional members may be admitted only upon the unanimous written consent of the existing members, and such existing members shall determine the amount and nature of contributions by new members at the time such new members are admitted.

**ARTICLE VII**

**CESSATION OF MEMBERSHIP**

The cessation of membership of one or more members will not result in dissolution of the Company.

**ARTICLE VIII**

**MANAGEMENT**

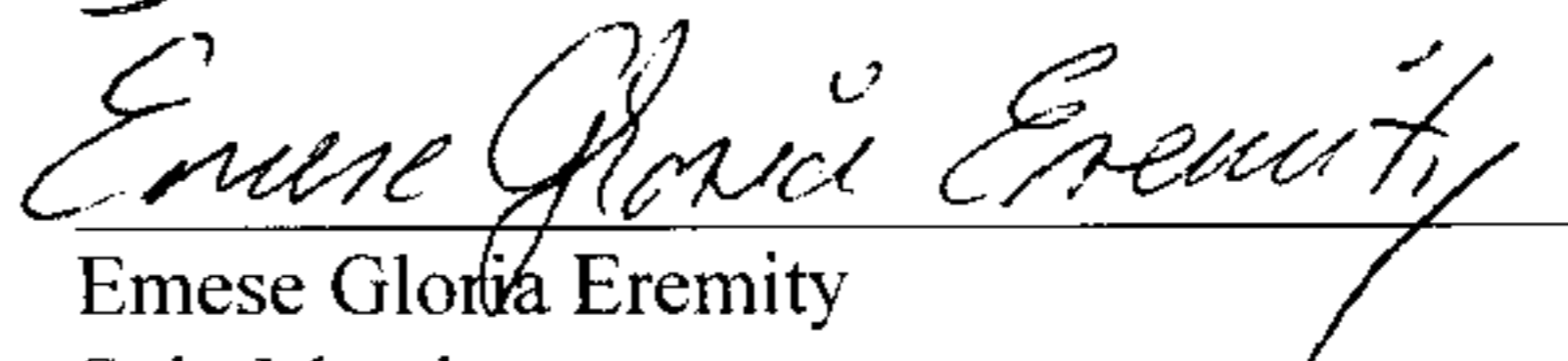
The Company shall be managed by its sole member. In the event that additional members are admitted pursuant to Article VI, the Company shall be managed by its members, with each member having an equal right to participate in such management.


**ARTICLE VIII**

**POWERS**

The Company shall have the same powers as a natural person to do all things necessary or convenient to carry out its business and affairs, including, without limitation, the powers set forth in §10-12-4, Code of Alabama (1975), as the same may hereafter be amended from time to time.

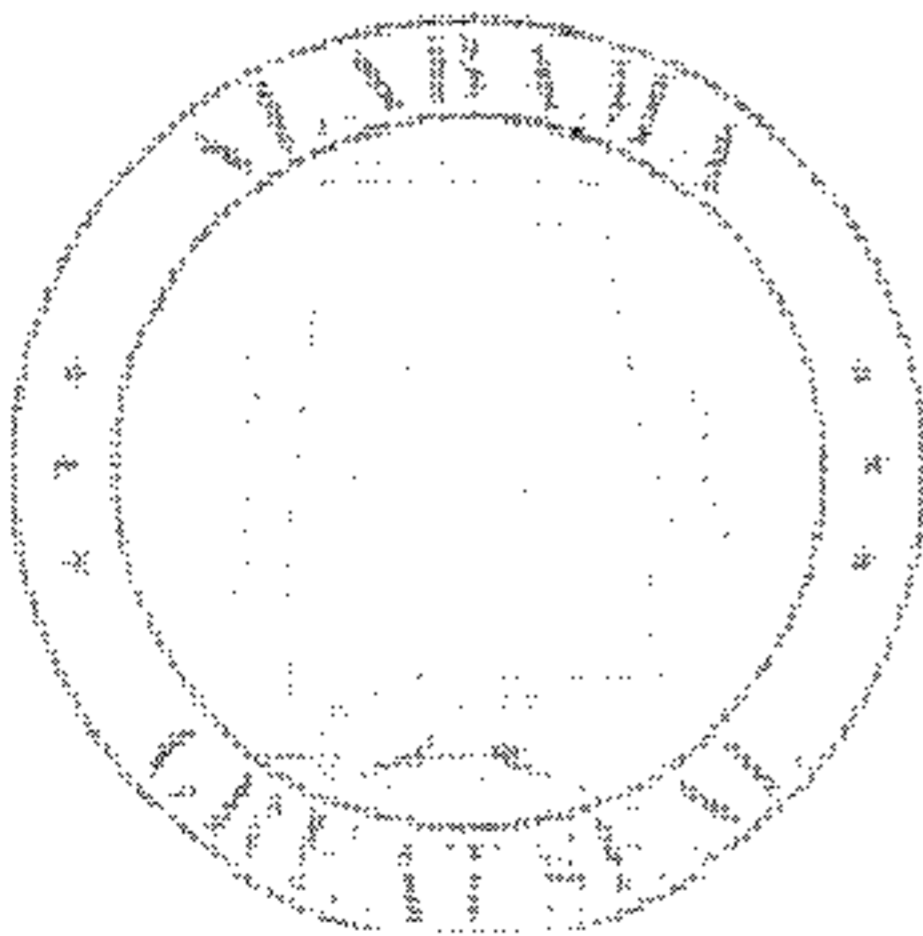
