


TO HAVE AND TO HOLD to Grantee, his heirs, executors, administrators and assigns forever.

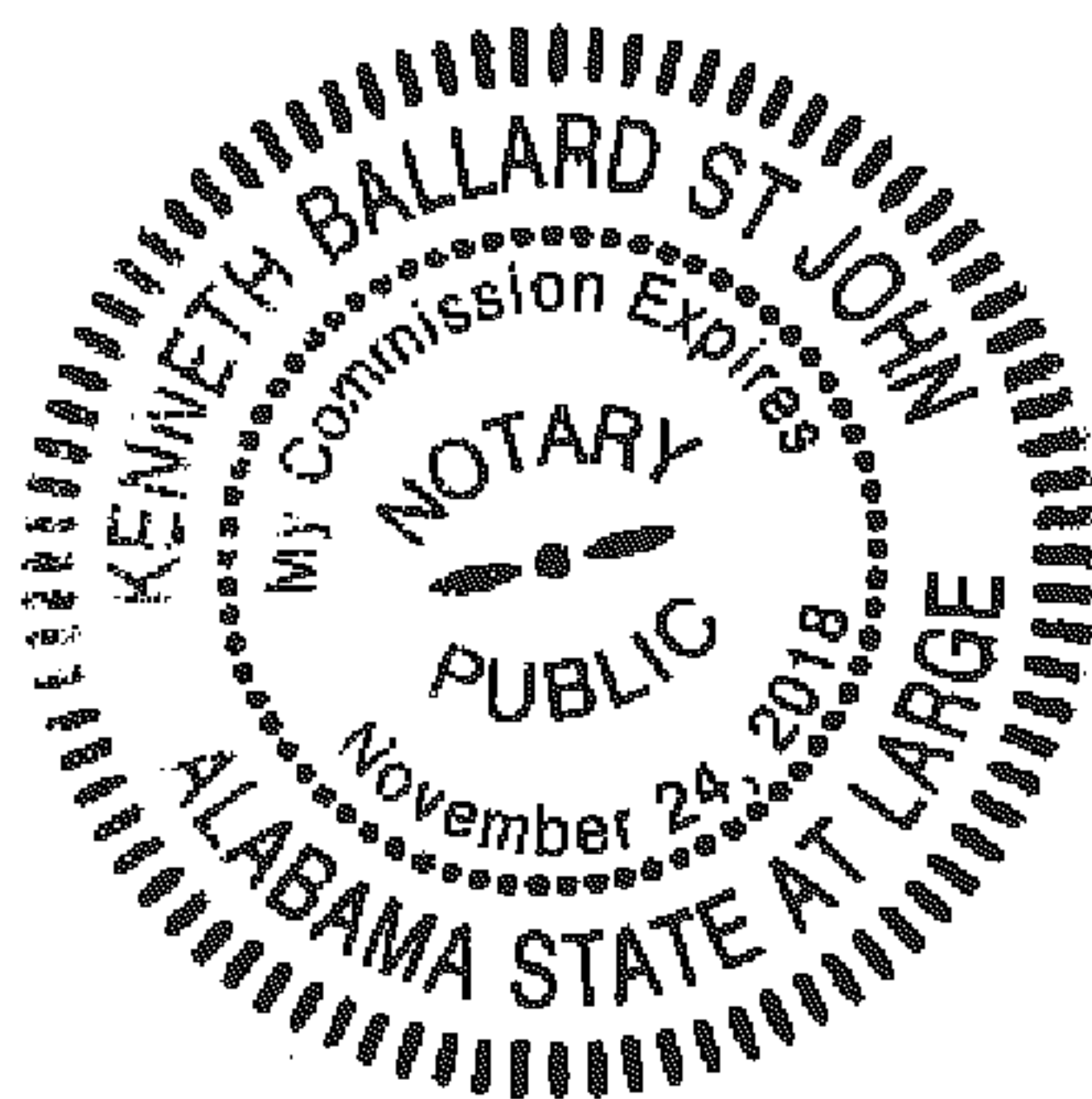




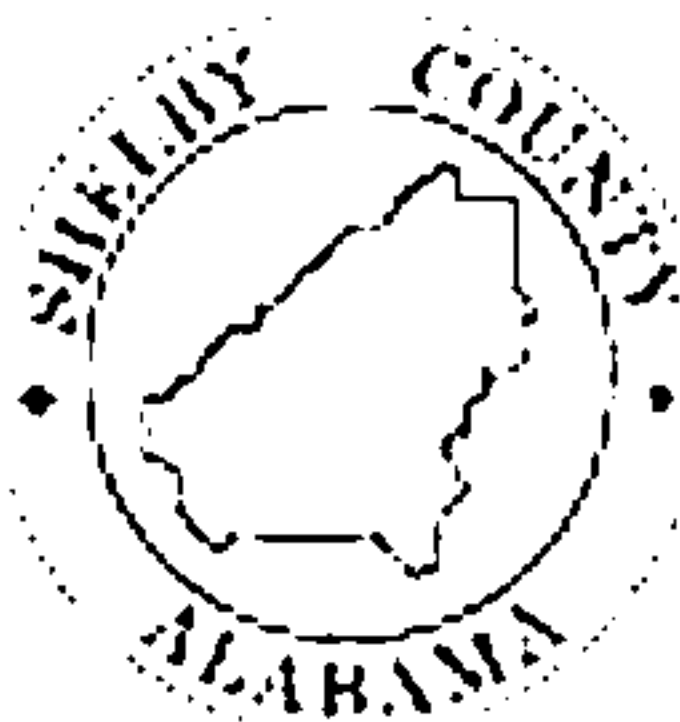
