Know All Men by These Presents: That in consideration of **One Hundred Fifty Thousand Nine Hundred Sixty and no/100 Dollars (\$150,960.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor), does hereby grant, bargain, sell and convey unto **SEAN C. 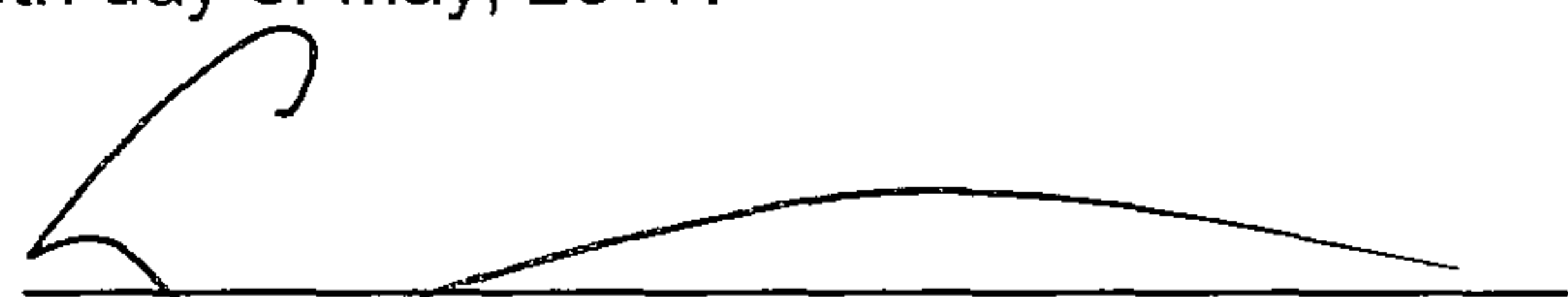

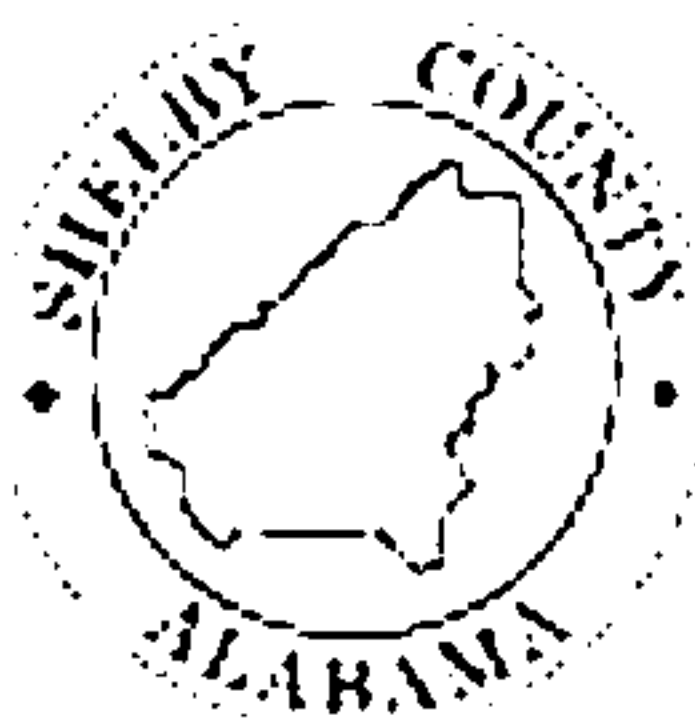
