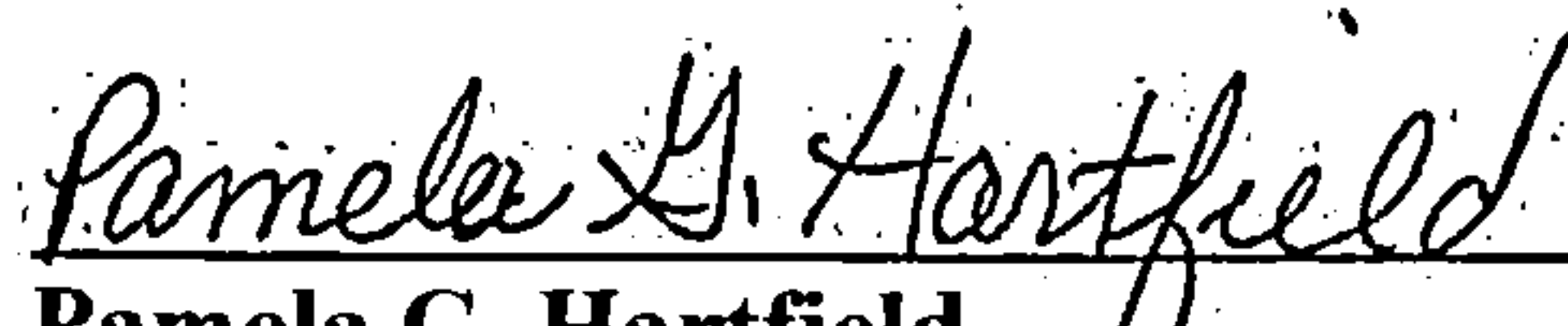
To have and to hold to the said grantee, as tenants in common, their heirs and assigns in fee simple, forever.

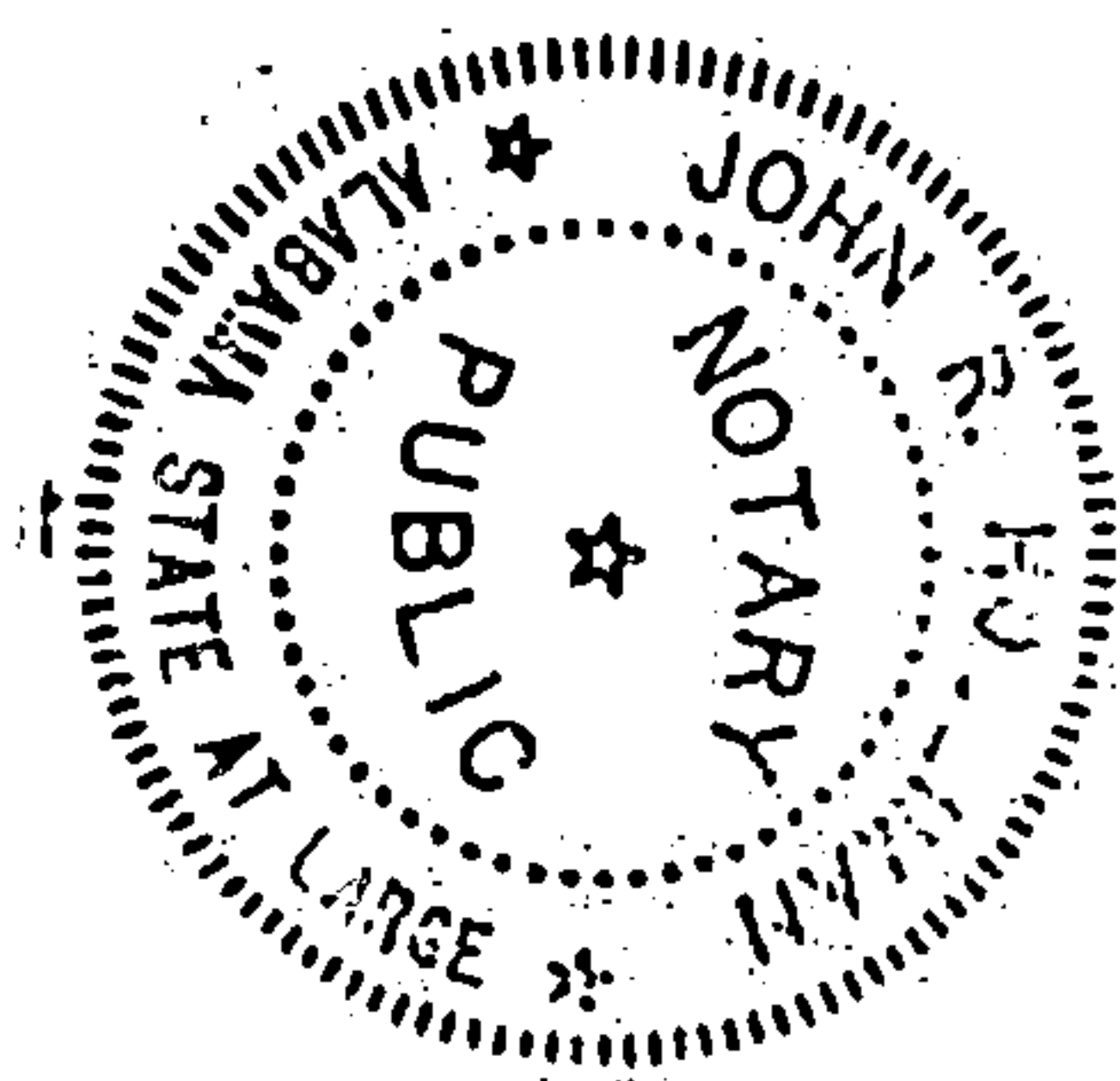

Commence at the SE Corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 17, Township 22 South, Range 1 West, Shelby County, Alabama, said Point being the POINT OF BEGINNING; thence S $00^{\circ}20'08''$ W along the $\frac{1}{4}$ - $\frac{1}{4}$ line, a distance of 284.89' to a point, said point lying on the Northerly R.O.W. of The Heart of Dixie Railroad (100' R.O.W.) that has been abandoned, said point also being the beginning of a non tangent curve to the right, having a radius of 904.97', a central angle of $46^{\circ}07'16''$, and subtended by a chord which bears S $87^{\circ}04'52''$ W, and a chord distance of 708.96'; thence along the arc of said curve and said R.O.W., a distance of 728.47'; thence N $00^{\circ}01'04''$ W and leaving said R.O.W., a distance of 1,031.91'; thence N $88^{\circ}48'59''$ E, a distance of 714.43'; thence S $00^{\circ}20'08''$ W along the $\frac{1}{4}$ - $\frac{1}{4}$ line a distance of 725.69' to the POINT OF BEGINNING.
