KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One-hundred sixty-nine thousand nine-hundred (\$169,900.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Stephanie Duncan and husband, William Casey Duncan (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Danny Dunaway and Tommie Dunaway (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 5, according to the Map and Survey of Southernhills, Sector 3, recorded in Map Book 14, Page 96, in the Office of the Judge of Probate of Shelby County, Alabama.

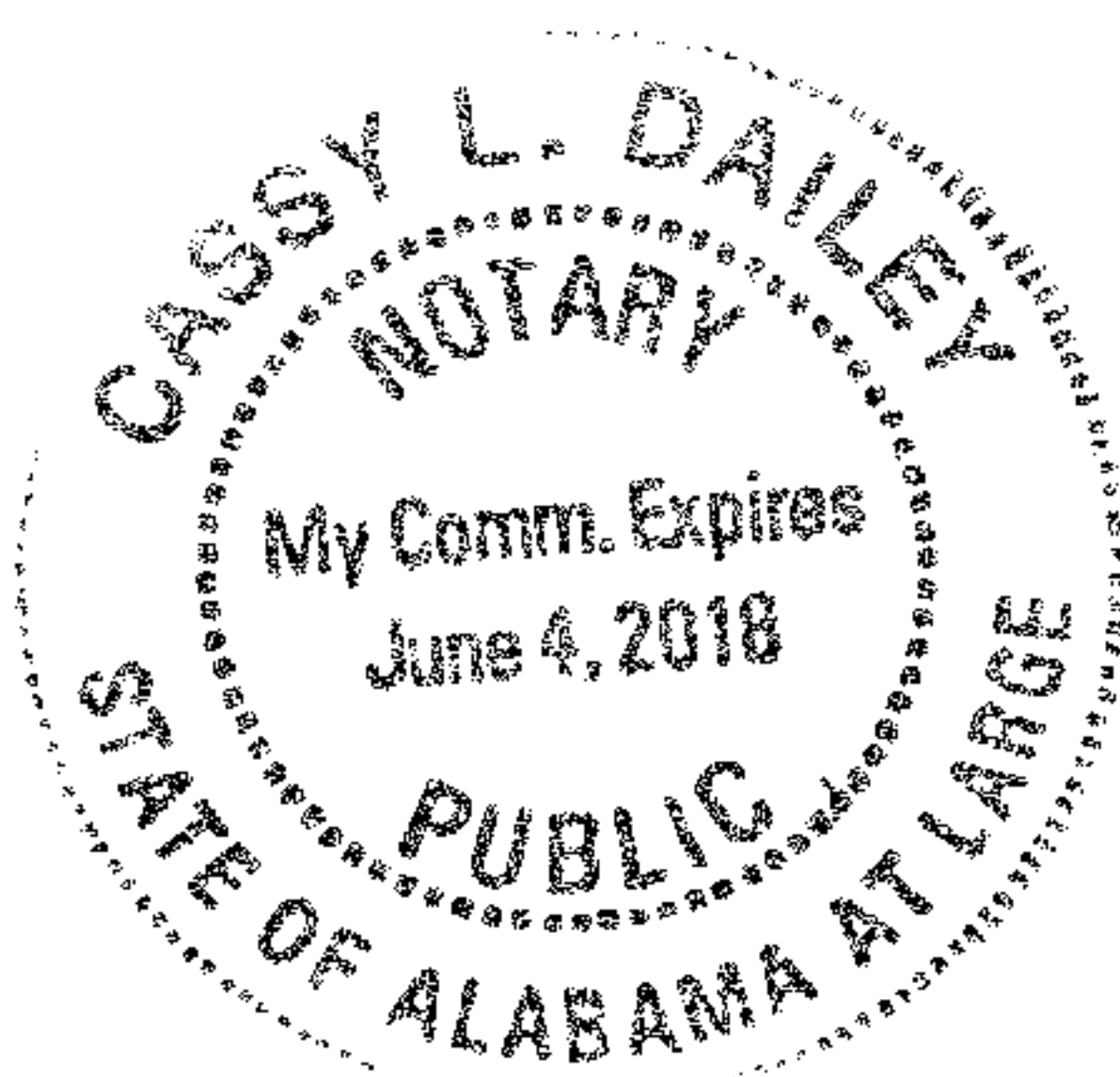

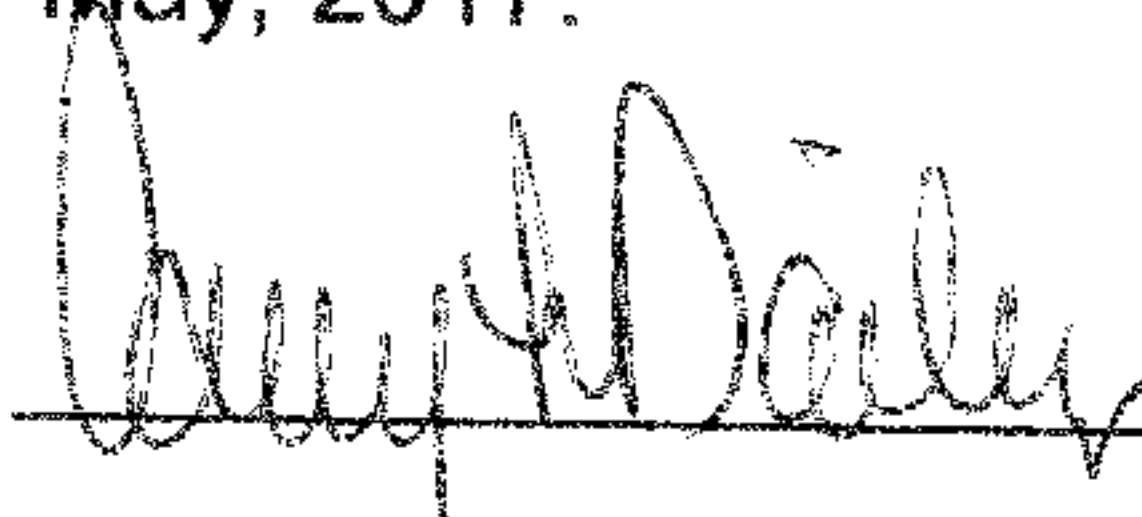

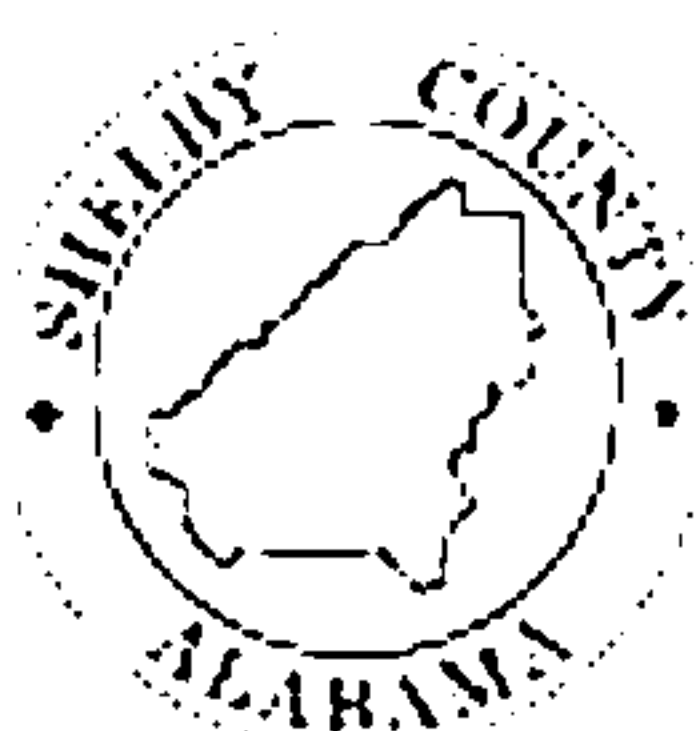
