

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, heretofore on, August 18, 2014, to wit, Nathan McCurley, an unmarried man, executed and delivered Mortgage Electronic Registration Systems, Inc. ("MERS"), (solely as nominee for Lender, Home Mortgage of America, Inc., and Lender's successors and assigns), a mortgage conveying to Mortgage Electronic Registration Systems, Inc. WHEREAS, Federal National Mortgage Association, organized and existing under the laws of the United States of America, being the highest, best and last bidder at said sale, became the purchaser of said property at and for the sum of One Hundred Sixty Eight Thousand One Hundred and No/100 Dollars (\$168,100.00).
