

**ARTICLES OF ORGANIZATION/CERTIFICATE OF FORMATION  
OF

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (the Act), hereby adopt the following Articles of Organization/Certificate of Formation for **BER INVESTMENT PROPERTIES, L.L.C.** (the Company).


