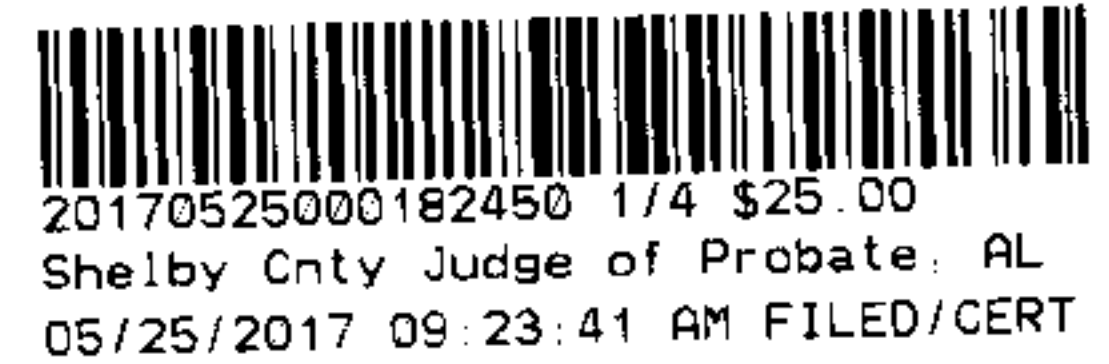

day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto

Commencing at the NE corner of the SW ¼ of the NW ¼ of Section 15, Township 19 South, Range 2 West; run thence N 88°34'09" W a distance of 57.30 feet, more or less, run thence S 01°25'51" W a distance of 161.86 feet, more or less, to the Point of Beginning; run thence S 38°25'09" E a distance of 10.00 feet, more or less; run thence on a curve to the right having a radius of 3789.91 feet, a curve distance of 169.28 feet, and a chord bearing S 52°33'35" W at a distance of 169.25 feet; run thence N 41°48'53" W a distance of 5.87 feet, more or less, run thence on a curve to the left having a radius of 2250.00 feet, a curve distance of 124.25 feet, and a chord bearing N 52°34'43" E at a distance of 124.24 feet; run thence N 50°59'49" E a distance of 39.72 feet; run thence N 23°30'54" E a distance of 6.40 feet, more or less, to the Point of Beginning; Containing 0.025 acres, more or less.

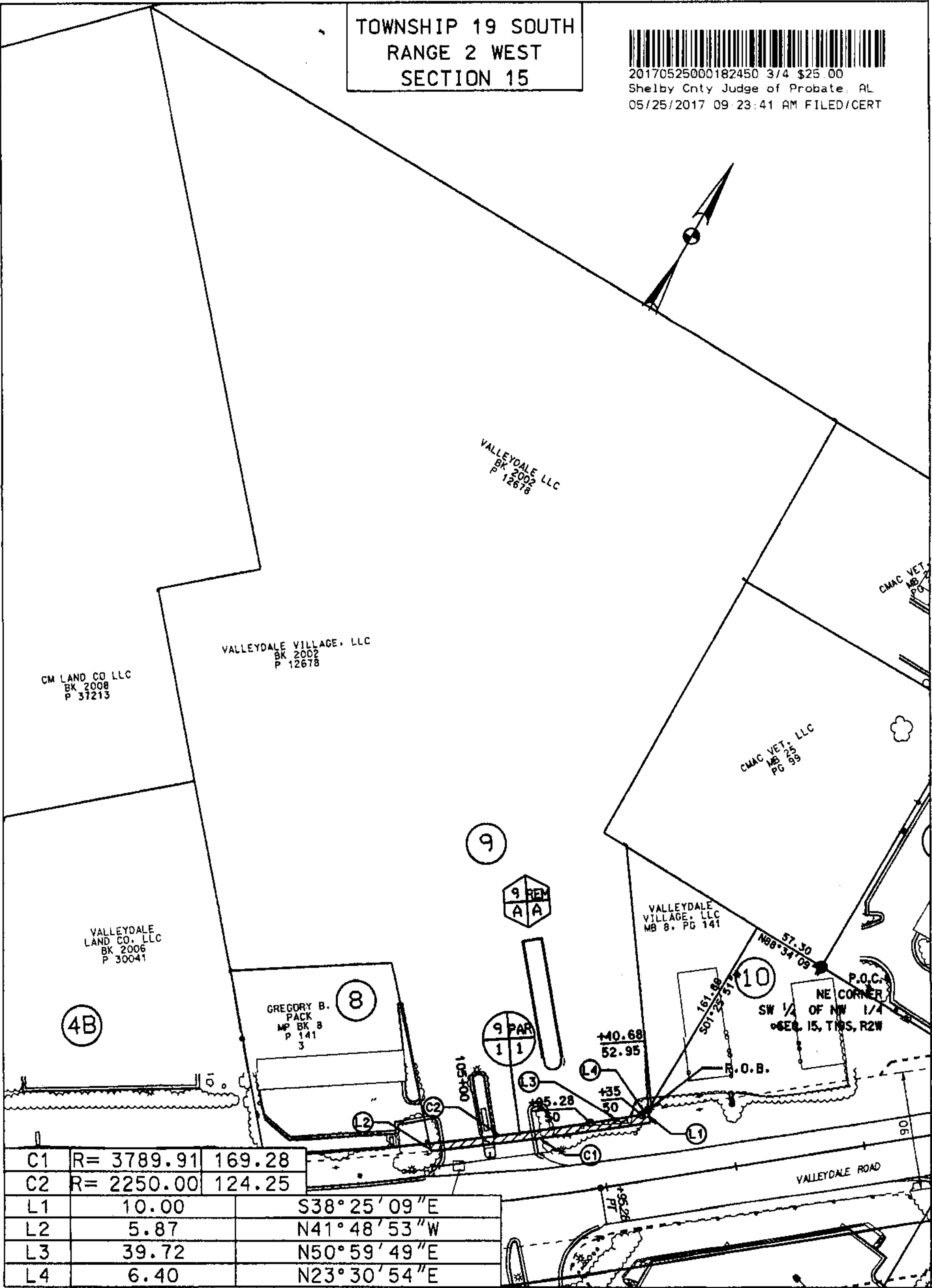
