The Association claims a lien upon property owned by **Dennis & Debra Lilly**, situated in Shelby County, Alabama described as follows:

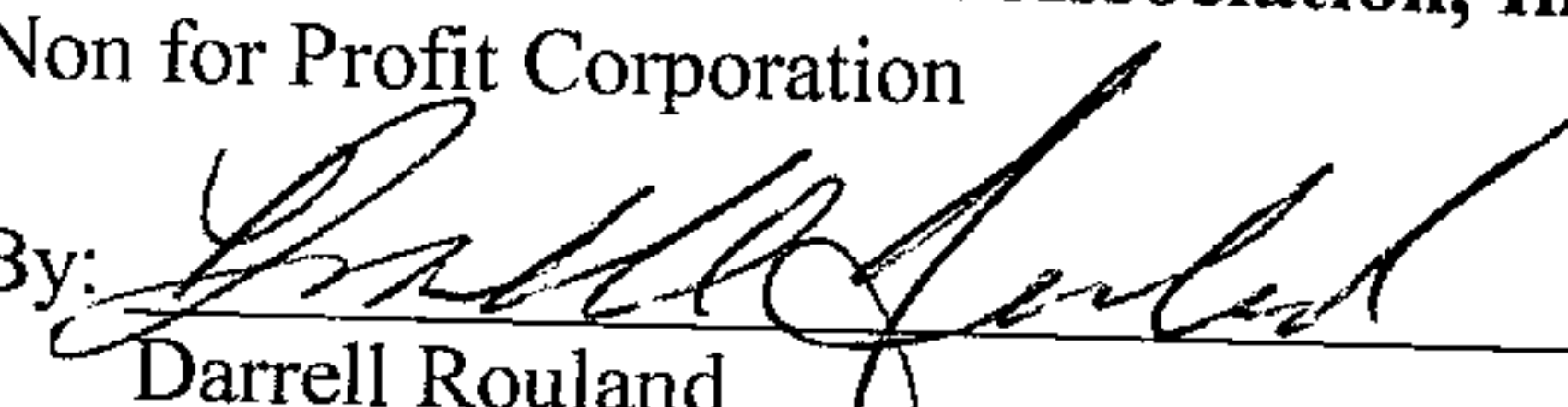

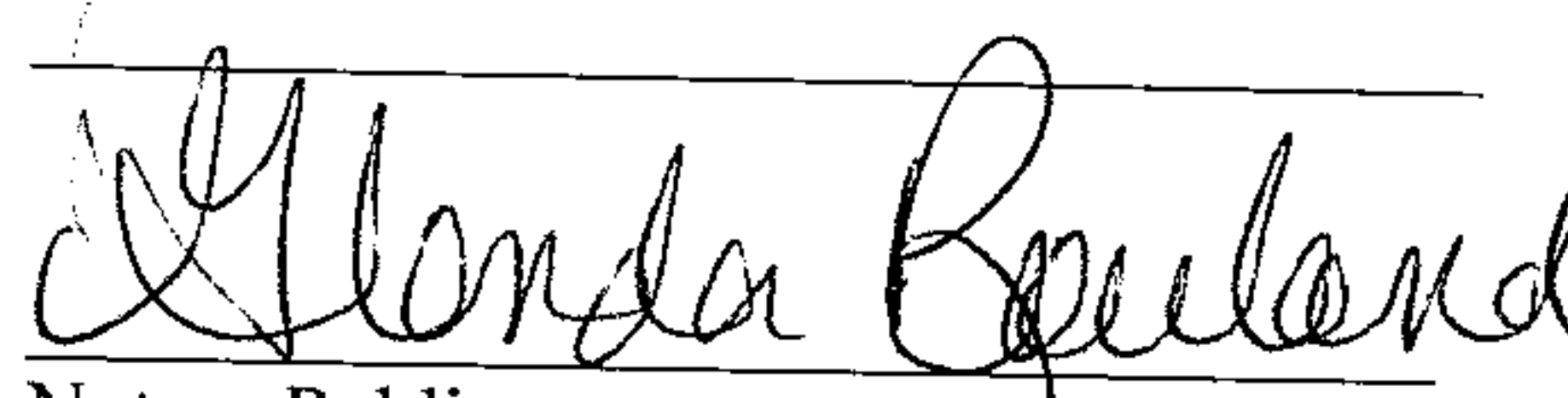
