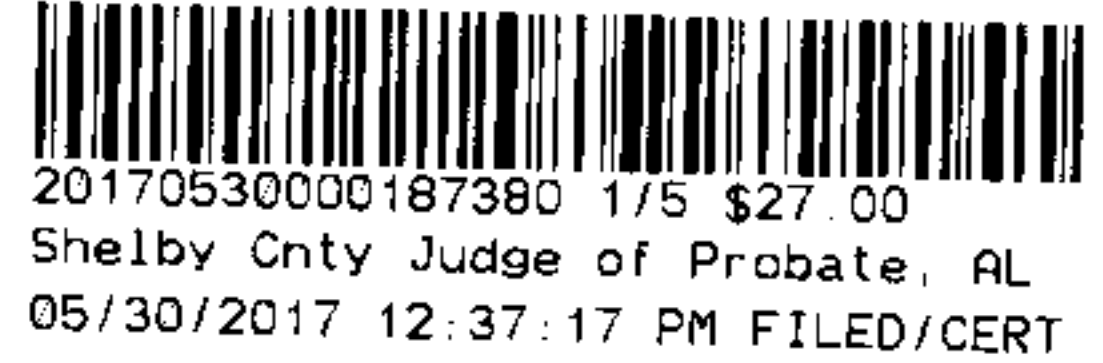

FINAL DECREE ON SETTLEMENT

This matter was set for hearing on the 29th day of June, 2016 at 1:30 p.m on the Successor Administratrix's application for Final Settlement and other relief. The equity jurisdiction of the Court has been invoked and is applied to the Final Settlement and Agreement thereon.

1. The Court notes that the parties have entered into a written Settlement Agreement (attached as Exhibit A) on all pending issues. Said Agreement has been signed and agreed to by Robin Alford and approved by her attorneys of record, M. Wayne Wheeler and J. Cooper Trent, II; and Charlotte Payne and approved by her attorney her attorney of record, William E. Swatek. Prior to the parties signing a Settlement Agreement, Philip Dennis signed a Consent for Final Settlement that is filed of record.

The Court having considered the parties' Settlement Agreement presented and filed of record finds that relief is due to be granted. It is therefore **Ordered, Adjudged, and Decreed** as follows:

2. The Settlement Agreement (Exhibit A) is ratified, approved and adopted by this Court.

3. The Successor Administratrix and all other parties are authorized, directed and ordered to take all actions necessary to comply with the terms, conditions and obligations of the Settlement Agreement.

4. The Court finds that Estate of William W. Dennis and the final accounting of Robin Alford is hereby passed and the estate is closed. This Order shall be a Final Judgment and Settlement of all pending issues.

5. That from the remaining cash assets on hand of Sixty Eight Thousand and Four Hundred Forty Seven and 00/100ths (\$68,447.00) (now being held in the Regions bank estate account), the Administratrix shall disburse the following, after first paying priority expenses of administration:

- a. The payment of Court cost taxed to and paid by the Administratrix to the Probate Court in the sum of \$189.42.
- b. The Payment of the Sum of Two Thousand Five Hundred Dollars and 00/100th (\$2,500.00) shall be paid to William E. Swatek as attorney fees for the Estate. Charlotte Faye Payne shall not receive any interest or funds from the Estate.
- c. The payment of all legal fees now approved by the Court to J. Cooper Trent, II and M. Wayne Wheeler.

6. That the Administratrix shall pay from the net remaining balance, after the above payments, one half of said balance to Robin Alford and one half of said balance to Philip Dennis,

7. That a Monetary Judgment is hereby entered and established against Charlotte Faye Payne in the amount of Forty Three Thousand Dollars and 00/100ths (\$43,000.00) in favor of Robin Alford and Philip Dennis.

Court costs are taxed to the Estate of William W. Dennis for which execution may issue.
