TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a limited liability company under the laws of the State of Alabama, does hereby adopt the following Certificate of Formation (the “Certificate of Formation”) to file with the probate judge of the County in which the initial registered office of the limited liability company will be located, and attests that the facts stated in the Certificate of Formation are true and correct:

ARTICLE I
NAME

The name of the limited liability company shall be **18TH STREET DEVELOPMENT GROUP, LLC**
(the “Company”).

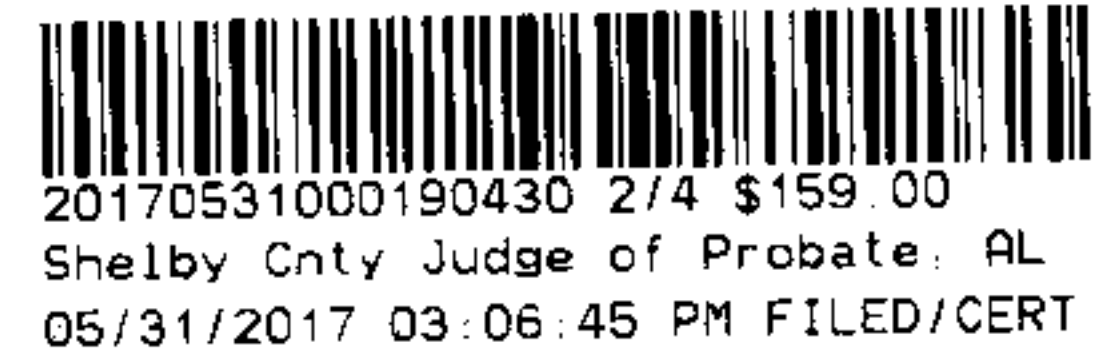
ARTICLE II
ORGANIZATION

The Company is hereby organized in accordance with the Alabama Limited Liability Company Law of 2014, Section 10A-5A-1.01 et seq., Code of Alabama, 2011, as amended from time to time (the “LLC Law”).

ARTICLE III
PERIOD OF DURATION

The term for which the Company is to exist as a limited liability company shall be effective on the date this Certificate of Formation is filed in the office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetual existence or until the Company shall be dissolved (a) upon the written consent of all Members of the Company, (b) as provided in the Limited Liability Company Agreement of the Company (the “LLC Agreement”), or (c) as may be required by the LLC Law or other applicable laws.

ARTICLE IV
LOCATION OF REGISTERED OFFICE
AND NAME OF REGISTERED AGENT



The location and mailing address of the initial registered office of the Company shall be at 103 Perry Place, Birmingham, Alabama 35242. The name of the initial registered agent at such address for service of process on the Company in the State of Alabama shall be Nick R. Pihakis.

ARTICLE V
MEMBERS

The Company may have one or more classes of members as provided in the LLC Agreement. The Company has at least one member, and the names and addresses of the initial member(s) of the Company (the "Members") are set forth in the LLC Agreement. The initial interests of the Members in the Company (the "Company Interests") shall be as set forth in the LLC Agreement. Subject to the terms and conditions of the LLC Agreement, the Members reserve the right to admit additional Members upon the unanimous agreement of the Members as to the admission of, and the consideration to be paid by such new Members.

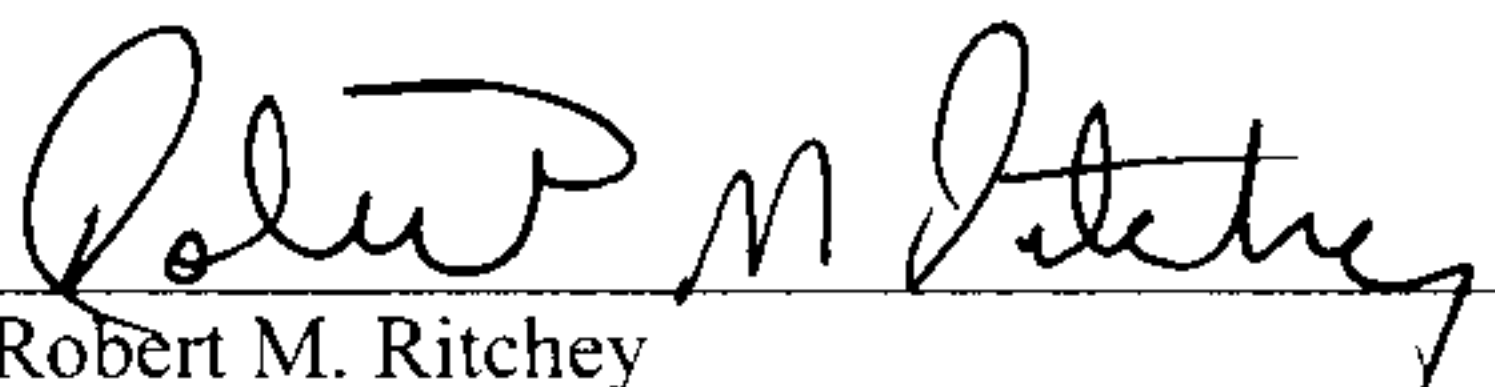

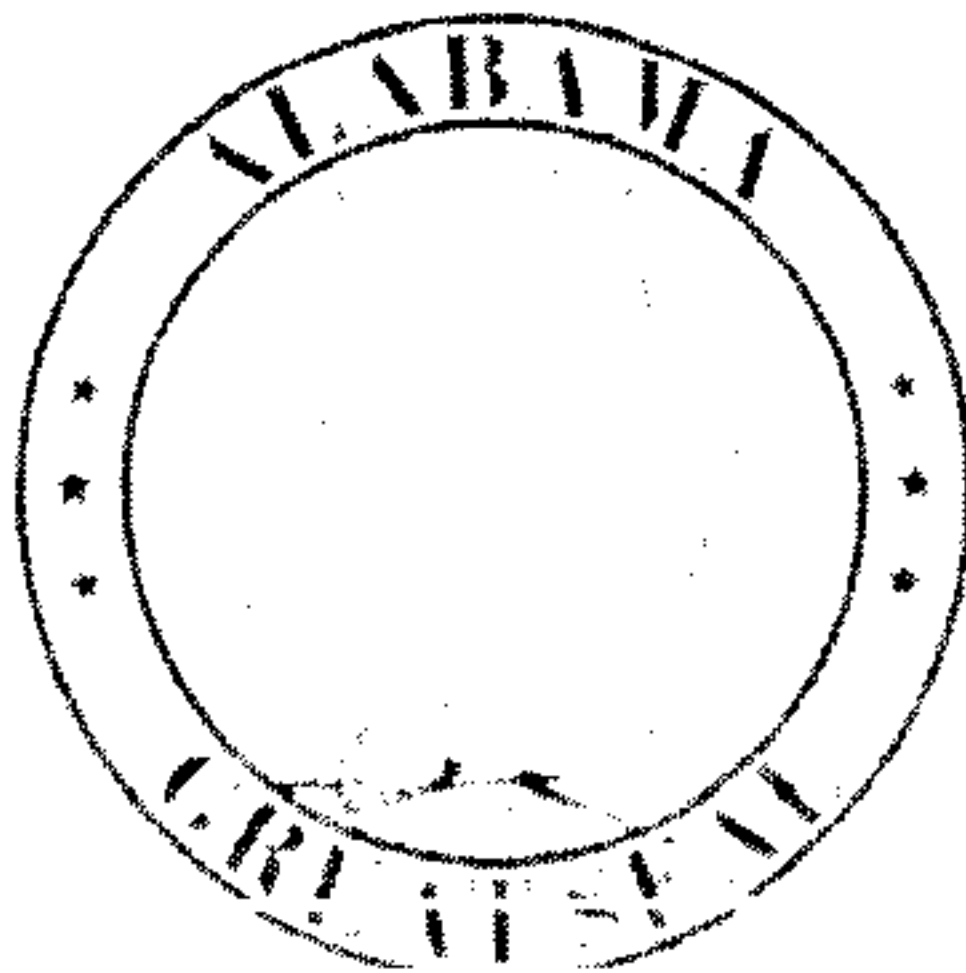
