The undersigned incorporator does hereby form a corporation under the Alabama Business Corporation Law, and does declare:

**ARTICLE I
NAME**

The name of the Corporation shall be B. Christina Agency, Inc.

**ARTICLE II
TYPE OF ENTITY**

The type of entity being formed is a business corporation.

(a) The name and address of the person who is to serve as the initial Director until the first annual meeting of shareholders, or until a successor is elected and qualified, is as follows:

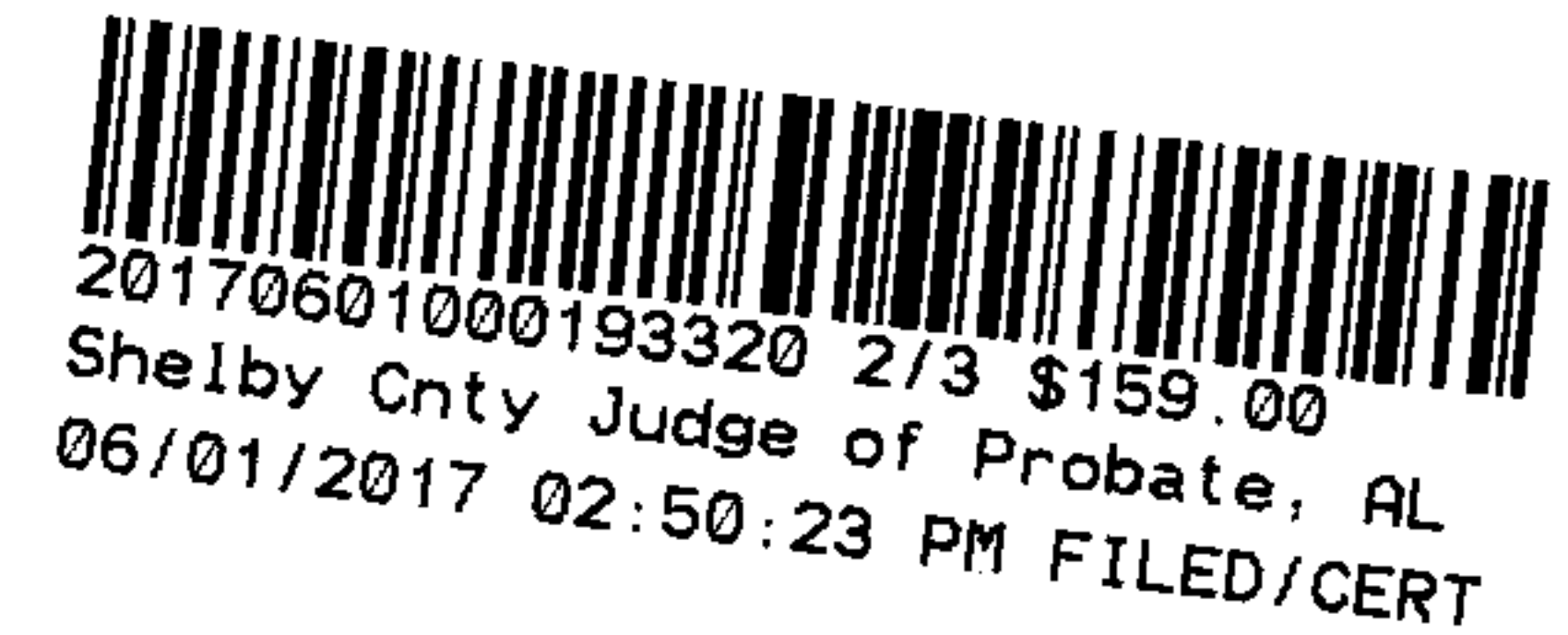
