KNOW ALL MEN BY THESE PRESENTS,

On this May 26, 2017, That for and in consideration of **TWO HUNDRED THREE THOUSAND NINE HUNDRED AND NO/100 (\$203,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **BRAXTON C. JETT and ASHLEY JETT, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **DESTRY WATSON and JANET WATSON**, ((herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 75, according to the Amended Final Record Plat of Narrows Peak Sector, as recorded in Map Book 31, Page 125 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 31, Page 125 A & B.




